4 **RESOLUTION 2021-90**

5 A RESOLUTION SUPPORTING SENATE BILL 78,
6 DESIGNATING A PORTION OF STATE ROAD U.S.
7 90/BEAVER STREET BETWEEN CHAFFEE ROAD AND U.S.
8 301 IN DUVAL COUNTY AS "JOHN B. COXWELL MEMORIAL
9 HIGHWAY"; DIRECTING THE CHIEF OF LEGISLATIVE
10 SERVICES TO SEND A COPY OF THIS RESOLUTION UPON
11 ADOPTION TO THE FLORIDA DEPARTMENT OF
12 TRANSPORTATION, DUVAL LEGISLATIVE DELEGATION,
13 THE SENATE PRESIDENT AND THE SPEAKER OF THE
14 HOUSE; PROVIDING AN EFFECTIVE DATE.

16 **WHEREAS**, during the 2020 Legislative Session, the Florida
17 Legislature passed Senate Bill 78, which makes honorary designations
18 of transportation facilities through Florida and directs the Florida
19 Department of Transportation (FDOT) to erect suitable markers for
20 those designations; and

21 **WHEREAS**, Senate Bill 78 designates that portion of State Road
22 U.S. 90/Beaver Street between Chaffee Road and U.S. 301 as "John B.
23 Coxwell Memorial Highway"; and

24 **WHEREAS**, Section 334.071, *Florida Statutes*, provides that a city
25 or county must pass a resolution in support of a particular
26 designation before road markers are erected; and

27 **WHEREAS**, the City of Jacksonville wishes to honor John B. Coxwell
28 and requests that the Florida Department of Transportation erect
29 suitable markers designating a portion of U.S. 90/Beaver Street
30 between Chaffee Road and U.S. 301 in Duval County as "John B. Coxwell
31 Memorial Highway"; now therefore

1 **BE IT RESOLVED** by the Council of the City of Jacksonville:

2 **Section 1.** The City Council strongly supports Senate Bill
3 78, and designation of a portion of U.S. 90/Beaver Street between
4 Chaffee Road and U.S. 301 as the "John B. Coxwell Memorial Highway."

5 **Section 2. Direction to Chief of Legislative Services.** The
6 Chief of Legislative Services for the City Council is hereby directed
7 to provide a copy of this resolution upon adoption to the Florida
8 Department of Transportation, Duval County Legislative Delegation,
9 Senate President and the Speaker of the House.

10 **Section 3. Effective Date.** That this Resolution shall
11 become effective upon signature by the Mayor or upon becoming
12 effective without the Mayor's signature.
