5 AN ORDINANCE APPROPRIATING \$420,318.00 FROM THE
6 SPECIAL LAW ENFORCEMENT TRUST FUND (THE "FUND")
7 INCLUDING \$400,318.00 TO PROCURE CAPITAL AND
8 OTHER EQUIPMENT FOR VARIOUS JACKSONVILLE
9 SHERIFF'S OFFICE DIVISIONS AND FACILITIES AS
10 MORE PARTICULARLY OUTLINED HEREIN, AND
11 \$20,000.00 TO PROVIDE CONTINUATION FUNDING TO
12 THE HOMEWARD BOUND PROGRAM; PURPOSE OF
13 APPROPRIATION; PROVIDING AN EFFECTIVE DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Appropriation.** For the 2021-2022 fiscal year,
17 within the City's budget, there is hereby appropriated the indicated
18 sum(s) from the account(s) listed in subsection (a) to the account(s)
19 listed in subsection (b):

26 (c) Explanation of Appropriation:

27 The funding above represents an appropriation of
28 \$420,318.00 from the Special Law Enforcement Trust Fund
29 including \$400,318.00 to procure capital and other
30 equipment for various Jacksonville Sheriff's Office
31 divisions and facilities and providing \$20,000.00 in

1 continuation funding for the Homeward Bound Program.

2 **Section 2. Purpose.** The purpose of the appropriation in
3 Section 1 is to provide funding to procure capital and other equipment
4 for various Jacksonville Sheriff's Office divisions and facilities
5 including: (1) \$34,322.00 for security camera upgrades for
6 Jacksonville Sheriff's Office facilities; (2) \$63,858.00 for Patrol
7 non-capital equipment; (3) \$102,641.00 for Patrol capital equipment;
8 (4) \$122,673.00 for Investigations capital equipment; and (5)
9 \$76,824.00 for Corrections capital equipment.. In addition, this
10 appropriation includes \$20,000.00 to provide continuation funding for
11 the Homeward Bound Program.

12 **Section 3. Effective Date.** This Ordinance shall become
13 effective upon signature by the Mayor or upon becoming effective
14 without the Mayor's signature.
