THE MONCRIEF ORDINANCE REGARDING ΑN AREA BUSINESS IMPROVEMENT PROGRAM; EXPANDING THE MONCRIEF AREA BUSINESS IMPROVEMENT PROGRAM -PHASE 1 GEOGRAPHIC AREA ESTABLISHED IN ORDINANCE 2021-282-E AND AMENDED BY ORDINANCE 2022-264-E; RENAMING THE EXPANDED GEOGRAPHIC AREA AS THE "MYRTLE-MONCRIEF-AVENUE B BUSINESS CORRIDOR" RENAMING THEPROGRAM AS THE "MYRTLE-MONCRIEF-AVENUE B BUSINESS CORRIDOR IMPROVEMENT PROGRAM" (THE "PROGRAM"); AUTHORIZING THE CARRYOVER OF PREVIOUSLY APPROPRIATED FUNDS FOR THE PROGRAM IN THE TOTAL AMOUNT OF \$1,171,000 UNTIL EXPENDED OR THROUGH SEPTEMBER 30, 2027, WHICHEVER OCCURS FIRST; PROVIDING FOR OVERSIGHT BY THE OFFICE ECONOMIC DEVELOPMENT; REQUESTING ONE EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

on June 8, 2021, the City Council approved Ordinance WHEREAS, 2021-282-E creating the Moncrief Area Business Improvement Program - Phase 1 to provide funding for grants to struggling businesses in the area to improve the visual and structural appearance of properties and structures within the business improvement area; and

WHEREAS, the Fiscal Year 2020-2021 annual budget, adopted by Ordinance 2020-504-E, originally appropriated \$150,000 to support the program; subsequently, Ordinance 2021-282-E appropriated these funds

to a more unique account and provided the qualifications and criteria for receipt of grant funds to assist with improvements to properties within the program area, including installation of landscaping, signage, façade enhancements, and parking lot improvements; and

WHEREAS, the Fiscal Year 2021-2022 annual budget, adopted by Ordinance 2021-504-E, appropriated an additional \$100,000 to the program; and

WHEREAS, on May 24, 2022, the City Council approved Ordinance 2022-264-E to expand the Moncrief Area Business Improvement Program-Phase 1 area, to revise the criteria for receipt of funds through the program, and to authorize the carryover of the previously appropriated \$250,000 to Fiscal Year 2022-2023; and

WHEREAS, the Fiscal Year 2022-2023 annual budget, adopted by Ordinance 2022-504-E, appropriated an additional \$499,000 to the program and the Fiscal Year 2023-2024 annual budget, adopted by Ordinance 2023-504-E, appropriated an additional \$422,000 for the program; and

WHEREAS, the funds appropriated prior to the start of Fiscal Year 2023-2024 did not include an authorization for the dollars to carry forward beyond Fiscal Year 2022-2023; and

WHEREAS, there is a continued need for funding opportunities that support the long term success of businesses in the Moncrief area and beyond and in an effort to meet this need, the Council desires to expand the Moncrief Area Business Improvement Program-Phase 1 area to include additional commercial properties in the corridors along Myrtle Avenue North and Moncrief Road, extending north to Avenue B; and

WHEREAS, this program supports continued economic and historical improvement in these neighborhoods which is vital to improving the health, safety and welfare of the citizens who live, work and play in the area; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Program - Phase 1 Geographic Area. The Council originally approved the Moncrief Area Business Improvement Program - Phase 1 geographic area pursuant to Ordinance 2021-282-E which included certain properties located on Myrtle Avenue North between 8th Street West and 9th Street West. The Council subsequently approved an expansion of the Moncrief Business Improvement Program Area pursuant to Ordinance 2022-264-E to include commercial parcels along Moncrief Road from 26th Street North into Voorhies Road to 45th Street West and back to Moncrief Road, and along Myrtle Avenue North from Kings Road to 26th Street North.

This Moncrief Area Business Improvement Program - Phase 1 is designed to assist businesses within the program area to improve the visual and structural appearance of their properties. Recognizing there are other businesses in the surrounding area that could benefit from access to funding for improvements to their commercial properties and structures, the Council desires to further expand the Moncrief Area Business Improvement Program - Phase 1 geographic area to now include certain properties along Moncrief Road from 45th Street to Avenue B as depicted on the on the map attached hereto as **Exhibit 1** and incorporated herein by this reference.

Section 2. Renaming the Program. The expanded geographic described in Section 1 shall now be known "Myrtle-Moncrief-Avenue B Business Corridor" and the program shall now be known as the "Myrtle-Moncrief-Avenue B Business Corridor Improvement Program" (the "Program"). The criteria to receive funding and the types of improvements that are authorized to be made using City grant funds awarded through this Program are outlined in Exhibit 2, attached hereto and incorporated herein by this reference.

Section 3. Carryover. All funds totaling \$1,171,000

previously appropriated for the Moncrief Area Business Improvement Program - Phase 1 are hereby authorized to carryover for the Program until expended or until September 30, 2027, whichever occurs first. This authorization will allow previously appropriated funding for grants for the Moncrief Area Business Improvement Program - Phase 1 to remain available for the newly expanded Myrtle-Moncrief-Avenue B Business Corridor Improvement Program.

Section 4. Oversight Department. The Office of Economic Development shall continue to have oversight of the Program as described herein.

Section 5. Requesting On Cycle Emergency Passage Pursuant to Council Rule 4.901 Emergency. One cycle emergency passage of this legislation is requested. The nature of the emergency is that businesses in the Program area wish to pursue the grant opportunities afforded by this Program as soon as possible to avoid loss of third-party financial assistance that may be available.

Section 6. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
