### **PROGRAM OVERVIEW:**

Jacksonville's immigrant population has steadily increased since the early 1990's. The city has seen significant increases in its European, Latino, and Asian immigrant populations. It is estimated that by 2050 approximately one quarter of the population will be foreign-born.

As the Florida immigrant population continues to grow, our mission is to support immigrants on their pathway to living informed, stable and civically engaged lives and our vision is to see immigrants participate wholly as citizens of the North East Florida community.

NEFIRA recognizes that local North East Florida immigrants need help in many ways. NEFIRA also recognizes that North East Florida has great many community programs, government resources, willing professionals and existing services that immigrants can benefit from. NEFIRA seeks to bridge the gap by creating systems to connect the available resources to immigrants through educational programs, stabilization resources and civic engagement opportunities.

# PROGRAM SCOPE OF WORK AND DELIVERABLES:

As part of the Program, NEFIRA will provide the following services:

- Free Citizenship Drives we host bi-yearly free citizenship events where we help Permanent Residents apply for Citizenship for free. We have previously worked with the City of Jacksonville, the University of North Florida, and the Florida Immigrant Coalition ("FLIC").
- English Civic Classes we work with existing community organizations such as the FLIC, the YMCA and Chets Creek Church to provide English Civic Classes to individuals looking to prepare for their Citizenship exam.
- First Time Voter Education we work with organizations such as FLIC and New Citizen to provide training to first time voters.
- English as a Second Language we work with existing community organizations such as the YMCA and Chets Creek Church to provide English for Speakers of Other Languages (ESOL) classes to individuals looking to improve their English skills.
- Financial Literacy Classes we work with banks such as Alive Credit Union, Certified Public Accountants, and financial advisors to provide training/literature for individuals looking to begin their personal financial management, budgeting, and investing.

- Higher Education Training we work with Florida State College at Jacksonville (FCSJ) to create bridge for access to vocational higher education.
- Maintain a Resource Catalog available to Program participants

## PROGRAM COSTS/PAYMENT TERMS:

City funds shall be expensed in accordance with the approved budget for the sole benefit of Duval County residents. Funds will be disbursed on a reimbursement basis upon the City's receipt and approval of required documentation including but not limited to paid invoices, cleared checks and bank statements.

Program Consultant Salary (Part-Time): \$40,000

Occupancy Expenses: \$120 Office Expenses: \$34,645 Travel Expenses: \$416 Equipment Expenses: \$1,000

## PROGRAM IMPACT & REPORTING:

To achieve the Program and NEFIRA goal of bridging the gap through educational programs, stabilization resources and civic engagement opportunities, we are developing and strengthening community partnerships with organizations such as the City of Jacksonville, the University of North Florida, the Florida Immigrant Coalition, YMCA, Chets Creek Church, New Citizen, FSCJ, Alive Credit Union, and private professionals. By hiring a Program Consultant that will be responsible for modifying and monitoring each of the sub-programs, we will be able to provide services to the community at a higher level.

The Program's achievements during the prior year included 2 Free Citizenship Drive Events, helping over 54 residents apply for their Citizenship. For FY 2024/25, we anticipate providing services to over 500 residents across the various Program activities.

Upon completion of the grant period, NEFIRA will provide the City with a report detailing the number of residents supported in achieving citizenship, the number and type of events held, and the results of participant surveys evaluating the effectiveness of the Program.

# ADDITIONAL GRANT REQUIREMENTS AND CONDITIONS:

Recipient's expenditure of City funds for the Program and the provision of services shall be subject to Chapter 118, Parts 1 – 5 of the *Jacksonville Ordinance Code*, and the terms and conditions of any contract entered into between the City and Recipient. Recipient shall use the City funds for the Program in accordance with the City Council approved Term Sheet and Program budget. The City's Grant Administrator may amend this Term Sheet or the approved Program budget consistent with the Program's needs, provided that any substantial change to this Term Sheet or a budget change not within 10% of the attached Program budget line-items will require City Council approval.
