5 AN ORDINANCE APPROVING AND AUTHORIZING THE  
6 MAYOR, OR HIS DESIGNEE, AND THE CORPORATION  
7 SECRETARY TO EXECUTE AND DELIVER THAT CERTAIN  
8 AIR POLLUTION CONTROL SPECIFIC OPERATING  
9 AGREEMENT BETWEEN THE STATE OF FLORIDA  
10 DEPARTMENT OF ENVIRONMENTAL PROTECTION (DEP) AND  
11 DUVAL COUNTY (THE "AGREEMENT"); PROVIDING FOR  
12 OVERSIGHT BY THE NEIGHBORHOODS DEPARTMENT,  
13 ENVIRONMENTAL QUALITY DIVISION; PROVIDING AN  
14 EFFECTIVE DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Approval and authorization.** There is hereby  
18 approved, and the Mayor, or his designee, and the Corporation  
19 Secretary are hereby authorized to execute and deliver for and on  
20 behalf of the City, that certain Air Pollution Control Specific  
21 Operating Agreement Between the State of Florida Department of  
22 Environmental Protection (DEP) and Duval County (the "Agreement"),  
23 in substantially the form as is attached hereto as **Exhibit 1** and  
24 incorporated herein by this reference. The Agreement delineates the  
25 respective responsibilities of parties to administer an efficient and  
26 effective local air quality protection program in accordance with the  
27 provisions of Section 403.182, Florida Statutes. The Agreement term  
28 commences upon execution of the contract by both parties and expires  
29 on August 31, 2024. This contract represents the continuation of a  
30 coordinated effort between the parties to address air quality at the  
31 local level, without duplication of efforts, dating back to June 3,

1 1982.

2           **Section 2.           Oversight.**           The Neighborhoods Department,  
3 Environmental Quality Division shall have oversight of the project  
4 described herein.

5           **Section 3.           Effective Date.**           This Ordinance shall become  
6 effective upon signature by the Mayor or upon becoming effective  
7 without the Mayor's signature.
