6 A RESOLUTION CONFIRMING THE APPOINTMENT OF  
7 KATHERINE MOORE, A DUVAL COUNTY RESIDENT AND  
8 FORMER GOVERNMENT EXECUTIVE WITH ETHICS  
9 EXPERIENCE, AS A MEMBER OF THE JACKSONVILLE  
10 ETHICS COMMISSION, PURSUANT TO SECTION 602.912,  
11 *ORDINANCE CODE*, APPOINTED BY THE STATE ATTORNEY  
12 FOR THE FOURTH JUDICIAL CIRCUIT REPLACING ROBYN  
13 BLANK FOR A PARTIAL TERM ENDING DECEMBER 31,  
14 2026, FOLLOWED BY A FULL TERM ENDING DECEMBER  
15 31, 2029; PROVIDING AN EFFECTIVE DATE.

17 **WHEREAS**, the State Attorney for the Fourth Judicial Circuit  
18 has nominated Katherine Moore to replace Robyn Blank as the State  
19 Attorney's appointee for a partial term ending December 31, 2026,  
20 followed by a full term ending December 31, 2029; and

21 **WHEREAS**, Ms. Moore meets the qualifications of Section  
22 602.912(d), *Ordinance Code*, as she is a former government executive  
23 with ethics experience and is currently a government executive  
24 specializing in ethics compliance; now therefore

25 **BE IT RESOLVED** by the Council of the City of Jacksonville:

26 **Section 1. Appointment Confirmation.** The Council hereby  
27 confirms the State Attorney for the Fourth Judicial Circuit's  
28 appointment of Katherine Moore, a Duval County resident and a current  
29 and former government executive with ethics experience meeting the  
30 requirements of Section 602.912(d), *Ordinance Code*, to the  
31 Jacksonville Ethics Commission, replacing Robyn Blank for a partial

1 term expiring December 31, 2026, followed by a full term ending  
2 December 31, 2029. Ms. Moore's resume is attached hereto as **Exhibit**  
3 **1.**

4 **Section 2. Effective Date.** This Resolution shall become  
5 effective upon signature by the Mayor or upon becoming effective  
6 without the Mayor's signature.
