5 AN ORDINANCE APPROPRIATING \$5,000,000,
6 INCLUDING A \$2,500,000 GRANT AWARDED BY THE
7 STATE OF FLORIDA DIVISION OF STATE FIRE
8 MARSHAL WITH A \$2,500,000 LOCAL MATCH FROM THE
9 CITY OF JACKSONVILLE FOR THE JACKSONVILLE FIRE
10 AND RESCUE DEPARTMENT HEALTH AND WELLNESS
11 CENTER (THE "PROJECT"), AS INITIATED BY B.T.
12 22-104; AMENDING THE 2022-2026 FIVE-YEAR
13 CAPITAL IMPROVEMENT PLAN APPROVED BY ORDINANCE
14 2021-505-E TO REFLECT THE STATE CONTRIBUTION
15 AND LOCAL FUNDING FOR THE PROJECT; PROVIDING
16 FOR OVERSIGHT BY THE JACKSONVILLE FIRE AND
17 RESCUE DEPARTMENT; PROVIDING AN EFFECTIVE
18 DATE.

20 **BE IT ORDAINED** by the Council of the City of Jacksonville:

21 **Section 1. Appropriation.** For the 2021-2022 fiscal year,
22 within the City's budget, there is hereby appropriated the
23 indicated sum(s) from the account(s) listed in subsection (a) to
24 the account(s) listed in subsection (b):

- 31 (c) Explanation of Appropriation:

1 The funding above represents an appropriation of grant
2 funding in the amount of \$2,500,000 from the Division of
3 State Fire Marshal with a \$2,500,000 local match for the
4 Jacksonville Fire and Rescue Department ("JFRD") Health
5 and Wellness Center.

6 **Section 2. Purpose.** The purpose of the appropriation in
7 Section 1 is to provide funding to procure and outfit a new
8 location for the JFRD Health and Wellness Center which provides a
9 central facility for a number of major health services including
10 medical fitness, injury/rehabilitation, and mental health (the
11 "Project"). The ability to provide these services from the current
12 location is limited by physical constraints of the building from
13 which the services are performed and offered. These funds will be
14 used to renovate, outfit and furnish a new location for the Health
15 and Wellness Center, including a significant investment to outfit
16 the facility to provide radiology services. A copy of the Division
17 of State Fire Marshal award letter and House Bill 3401 reflecting
18 the award of funding from the State are attached hereto as **Exhibit**
19 **2.**

20 **Section 3. Capital Improvement Plan Amendment.** Ordinance
21 2021-505-E, adopting the 2022-2026 Five-Year Capital Improvement
22 Plan (the "CIP") for the City and certain of its independent
23 agencies, is hereby amended to add the Health and Wellness Center
24 Project to the CIP and to reflect this funding for the Project as
25 more fully described in the Project Information Sheet attached
26 hereto as **Exhibit 3** and incorporated herein by this reference. The
27 City Council finds that the deferral of this amendment of the CIP
28 until the next annual budget and CIP review will be detrimental to
29 the best interests of the community because such deferral will
30 unnecessarily delay the ability to provide a comprehensive
31 occupational Firefighter Health and Wellness Center.

1 Pursuant to Section 122.605(c), *Ordinance Code*, enactment of
2 this Ordinance requires the affirmative vote of two-thirds of the
3 City Council members present at the meeting because of the CIP
4 amendment set forth in this section. This Ordinance shall
5 constitute an amendment to Ordinance 2021-505-E. In all other
6 respects, the Five-Year Capital Improvement Plan approved by
7 Ordinance 2021-505-E shall remain unchanged and continue in full
8 force and effect.

9 **Section 4. Oversight.** The Jacksonville Fire and Rescue
10 Department shall oversee administration of the grant and the
11 Project described herein.

12 **Section 5. Effective Date.** This Ordinance shall become
13 effective upon signature by the Mayor or upon becoming effective
14 without the Mayor's signature.
