7 AN ORDINANCE APPROPRIATING \$150,000.00 IN GRANT
8 FUNDING FROM THE FLORIDA DEPARTMENT OF LAW
9 ENFORCEMENT, THROUGH ITS FY 23-24 STATE
10 FINANCIAL ASSISTANCE FOR FENTANYL ERADICATION
11 (S.A.F.E.) IN FLORIDA PROGRAM, TO THE PSBU
12 GRANTS/OPERATION THREE CROWNS FY 23-24 PROJECT
13 TO COMBAT ILLEGAL FENTANYL ACTIVITY, AS
14 INITIATED BY B.T. 24-091; PROVIDING FOR
15 OVERSIGHT BY THE JACKSONVILLE SHERIFF'S OFFICE;
16 PROVIDING AN EFFECTIVE DATE.

18 **BE IT ORDAINED** by the Council of the City of Jacksonville:

19 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
20 within the City's budget, there are hereby appropriated the indicated
21 sum(s) from the account(s) listed in subsection (a) to the account(s)
22 listed in subsection (b):

29 (c) Explanation of Appropriation:

30 The funding above represents an appropriation of grant
31 funds from the Florida Department of Law Enforcement,

1 through its FY 23-24 State Financial Assistance for
2 Fentanyl Eradication (S.A.F.E.) in Florida Program, to the
3 Jacksonville Sheriff's Office PSBU Grants/Operation Three
4 Crowns FY 23-24 Project to combat illegal fentanyl
5 activity. The grant period commenced on July 1, 2023, and
6 continues through June 30, 2024. No local match is
7 required.

8 **Section 2. Purpose.** The purpose of the appropriation in
9 Section 1 is to utilize the Fentanyl and Opioid Eradication (FOE)
10 grant funding from the Florida Department of Law Enforcement through
11 its FY 23-24 State Financial Assistance for Fentanyl Eradication
12 (S.A.F.E.) in Florida Program, to conduct investigations designed to
13 combat illegal fentanyl activity and will cover expenses related to
14 overtime for such investigations. A copy of the Financial Assistance
15 Agreement outlining the terms and conditions relative to the grant
16 and use of the grant funds is attached hereto as **Exhibit 2** and
17 incorporated herein by this reference.

18 **Section 3. Oversight.** The Jacksonville Sheriff's Office
19 shall oversee administration of the grant and project described
20 herein.

21 **Section 4. Effective Date.** This Ordinance shall become
22 effective upon signature by the Mayor or upon becoming effective
23 without the Mayor's signature.
