5 A RESOLUTION CONFIRMING THE APPOINTMENT OF
6 JACKIE B. SCHEEL, A RESIDENT AND QUALIFIED
7 ELECTOR OF THE CITY OF JACKSONVILLE, AS A JEA
8 REPRESENTATIVE, TO THE CIVIL SERVICE BOARD,
9 FILLING A SEAT FORMERLY HELD BY EDYTHE M.
10 ABDULLAH, PURSUANT TO SECTION 17.02 (CIVIL
11 SERVICE BOARD), ARTICLE 17 (CIVIL SERVICE), PART
12 A (CHARTER LAWS CHARTER OF THE CITY OF
13 JACKSONVILLE, FLORIDA), *CHARTER OF THE CITY OF*
14 *JACKSONVILLE*, FOR A PARTIAL TERM EXPIRING ON
15 JUNE 30, 2027; PROVIDING AN EFFECTIVE DATE.

17 **WHEREAS**, subsection 17.02(b), *Charter of the City of*
18 *Jacksonville*, requires JEA to appoint two members to the Civil Service
19 Board; and

20 **WHEREAS**, on March 31, 2026, the JEA Board approved the
21 appointment of Jackie B. Scheel to the Civil Service Board for a
22 partial term expiring on June 30, 2027; and

23 **WHEREAS**, pursuant to Section 17.02(b), *Charter of the City of*
24 *Jacksonville*, appointments to the Civil Service Board are required
25 to be confirmed by the City Council; now therefore

26 **BE IT RESOLVED** by the Council of the City of Jacksonville:

27 **Section 1. Confirmation of Appointment.** The City Council
28 hereby confirms the appointment of Jackie B. Scheel, a resident and
29 qualified elector of the City of Jacksonville, as a JEA
30 representative, to the Civil Service Board, filling a seat formerly

1 held by Edyth M. Abdullah, pursuant to subsection 17.02 (Civil service
2 board), Article 17 (Civil Service), Part A (Charter Laws Charter of
3 the City of Jacksonville, Florida), *Charter of the City of*
4 *Jacksonville*, for partial term expiring on June 30, 2027. The JEA
5 Board approved the appointment of Jackie B. Scheel to the Civil
6 Service Board during its meeting on March 31, 2026, and a copy of JEA
7 Board Resolution 2026-14 and the Board meeting minutes are
8 collectively attached hereto as **Exhibit 1**.

9 **Section 2. Effective Date.** This Resolution shall become
10 effective upon signature by the Mayor or upon becoming effective
11 without the Mayor's signature.
