AN ORDINANCE APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER, AN AMENDMENT TO THE FISCAL YEAR 2023-2024 ARTICLE V TRUST FUND AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND JACKSONVILLE AREA LEGAL AID, INC. "AGREEMENT"), ORIGINALLY APPROVED AND AUTHORIZED BY ORDINANCE 2023-504-E, TO EXTEND THE TERM OF THE AGREEMENT TO EXPIRE ON DECEMBER 31, 2024; PROVIDING FOR CONTINUED OVERSIGHT BY THE GRANTS AND CONTRACT COMPLIANCE DIVISION OF THE FINANCE DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Ordinance 2023-504-E, the City's Fiscal Year 2023-2024 Budget, appropriated \$1,080,620 and authorized the Mayor, or her designee, and the Corporation Secretary to execute on behalf of the City an agreement with Jacksonville Area Legal Aid, Inc. ("JALA") for the provision of legal aid services to the residents of Duval County; and

WHEREAS, the Fiscal Year 2023-2024 Article V Trust Fund Agreement Between the City of Jacksonville and Jacksonville Area Legal Aid, Inc. (the "Agreement") expired on September 30, 2024, at which time \$27,812.48 remained unpaid to JALA for legal services pursuant to the Agreement; and

WHEREAS, during the period between September 30, 2024 and December 31, 2024, JALA continued to provide legal services however

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Approval and Authorization to Execute Amendment to Agreement. There is hereby approved, and the Mayor, or her designee, and the Corporation Secretary are hereby authorized to execute and deliver, an amendment to the Fiscal Year 2023-2024 Article V Trust Fund Agreement Between the City of Jacksonville and Jacksonville Area Legal Aid, Inc., originally approved and authorized by Ordinance 2023-504-E, to extend the term of the Agreement to December 31, 2024, with all other terms and conditions of the Agreement remaining unchanged.

Section 2. Oversight. The Grants and Contract Compliance Division of the Finance Department shall continue to have oversight of the Agreement described herein.

Section 3. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
