5 AN ORDINANCE APPROPRIATING \$60,000.00 FROM THE
6 DOWNTOWN INVESTMENT AUTHORITY GENERAL
7 OPERATING FUND, OTHER PROFESSIONAL SERVICES,
8 TO SUBSIDIES & CONTRIBUTIONS TO PRIVATE
9 ORGANIZATIONS, TO BE DISBURSED BY THE DOWNTOWN
10 INVESTMENT AUTHORITY BOARD CONSISTENT WITH THE
11 DIA BID PLAN, AS INITIATED BY B.T. 21-073;
12 PURPOSE OF APPROPRIATION; PROVIDING AN
13 EFFECTIVE DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Appropriation.** For the 2020-2021 fiscal year,
17 within the City's budget, there is hereby appropriated the
18 indicated sum(s) from the account(s) listed in subsection (a) to
19 the account(s) listed in subsection (b):

26 (c) Explanation of Appropriation:

27 The funding above provides for a transfer of funds from
28 the Downtown Investment Authority ("DIA") General
29 Operating Fund, Other Professional Services Account, to
30 the Subsidies & Contributions to Private Organizations,

1 to be allocated subsequently by the DIA Board.

2 **Section 2. Purpose.** The purpose of the appropriation in
3 Section 1 is to re-allocate \$60,000.00 of unused professional
4 service funding to provide for the ability of the DIA Board to
5 provide grant funding consistent with its CRA BID Plan. This
6 funding transfer is consistent with the original intent of the
7 appropriation of these dollars.

8 This appropriation was approved by the Downtown Investment
9 Authority Board on April 21, 2021 pursuant to Resolution 2021-04-
10 07, a copy of which is attached hereto as **Exhibit 2** and
11 incorporated herein by this reference.

12 **Section 3. Effective Date.** This Ordinance shall become
13 effective upon signature by the Mayor or upon becoming effective
14 without the Mayor's signature.
