5 AN ORDINANCE CONCERNING A CONTINUATION GRANT;
6 APPROPRIATING \$536,560.00 IN ANNUAL EMERGENCY
7 SOLUTIONS GRANT (ESG) FUNDING FROM THE U.S.
8 DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT TO
9 PROVIDE FUNDING TO: 1) ENGAGE HOMELESS
10 INDIVIDUALS AND FAMILIES LIVING ON THE STREET;
11 2) IMPROVE THE NUMBER AND QUALITY OF EMERGENCY
12 SHELTERS FOR HOMELESS INDIVIDUALS AND
13 FAMILIES; 3) HELP OPERATE THE SHELTERS; 4)
14 PROVIDE ESSENTIAL SERVICES TO SHELTER
15 RESIDENTS; 5) RAPIDLY RE-HOUSE HOMELESS
16 INDIVIDUALS AND FAMILIES; AND, 6) PREVENT
17 INDIVIDUALS AND FAMILIES FROM BECOMING
18 HOMELESS, AS INITIATED BY B.T. 20-001;
19 PROVIDING FOR AN EFFECTIVE DATE.

21 **BE IT ORDAINED** by the Council of the City of Jacksonville:

22 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
23 within the City's budget, there is hereby appropriated the
24 indicated sum from the account listed in subsection (a) to the
25 account listed in subsection (b):

1 (c) Explanation of Appropriation

2 The funding above in the amount of \$536,560.00 comprises
3 annual Emergency Solutions Grant (ESG) funding from the
4 U.S. Department of Housing and Urban Development to be
5 administered pursuant to 24 CFR 576.100(c).

6 **Section 2. Purpose.** The purpose of the appropriation in
7 Section 1 is to provide funding to: i) engage homeless individuals
8 and families living on the street; ii) improve the number and
9 quality of emergency shelters for homeless individuals and
10 families; iii) help operate the shelters; iv) provide essential
11 services to shelter residents; v) rapidly re-house homeless
12 individuals and families; and, vi) prevent individuals and families
13 from becoming homeless. The Schedule of Proposed Funding detailing
14 the proposed use of funds is attached hereto as **Exhibit 2** and
15 incorporated herein by this reference. A copy of the grant award
16 letter is attached hereto as **Exhibit 3** and incorporated herein by
17 this reference. A copy of the certified minutes excerpt of the
18 March 27, 2019 regular meeting of the Jacksonville Housing and
19 Community Development Commission is attached hereto as **Exhibit 4**
20 and incorporated herein by this reference.

21 **Section 3. Effective Date.** This ordinance shall become
22 effective upon signature by the Mayor or upon becoming effective
23 without the Mayor's signature.
