4 **ORDINANCE 2020-184-E**

5 AN ORDINANCE AUTHORIZING THE GRANTING OF A
6 NON-RESIDENTIAL SOLID WASTE COLLECTION AND
7 TRANSPORTATION FRANCHISE TO FREEDOM WASTE
8 MANAGEMENT LLC PURSUANT TO CHAPTER 380 (SOLID
9 WASTE MANAGEMENT), PART 6 (NONRESIDENTIAL
10 SOLID WASTE COLLECTION AND TRANSPORTATION
11 FRANCHISES), *ORDINANCE CODE*; PROVIDING FOR
12 OVERSIGHT BY THE SOLID WASTE DIVISION OF THE
13 DEPARTMENT OF PUBLIC WORKS; PROVIDING AN
14 EFFECTIVE DATE.

16 **WHEREAS**, Freedom Waste Management LLC has submitted an
17 application for a non-residential solid waste collection and
18 transportation franchise pursuant to the provisions of Chapter 380,
19 *Ordinance Code*; and

20 **WHEREAS**, the application was reviewed by the Solid Waste
21 Division of the Department of Public Works; and

22 **WHEREAS**, the Department of Public Works recommends granting a
23 franchise for non-residential solid waste collection and
24 transportation to Freedom Waste Management LLC; and

25 **WHEREAS**, granting a non-residential solid waste collection and
26 transportation franchise to Freedom Waste Management LLC will
27 further the purposes for which the franchise program was adopted,
28 including, but not limited to, safeguarding public health, safety,
29 and welfare in the collection and transportation of solid waste
30 through Jacksonville; now therefore

1 **BE IT ORDAINED** by the Council of the City of Jacksonville:

2 **Section 1. Franchise agreement authorized.** In accordance
3 with the provisions of Chapter 380 (Solid Waste Management), Part 6
4 (Nonresidential Solid Waste Collection and Transportation
5 Franchises), *Ordinance Code*, the Director of the Public Works
6 Department is hereby authorized to issue a franchise agreement to
7 Freedom Waste Management LLC to collect and transport non-
8 residential solid waste in the City of Jacksonville. Freedom Waste
9 Management LLC has paid the application fee of \$1,500.00. A copy of
10 the Non-residential Solid Waste Collection and Transportation
11 Franchise Agreement is attached hereto as **Exhibit 1** and
12 incorporated herein by this reference. A copy of the letter from
13 the Department of Public Works forwarding Freedom Waste Management
14 LLC's application to the Council for action is attached hereto as
15 **Exhibit 2** and incorporated herein by this reference.

16 **Section 2. Oversight.** The Solid Waste Division of the
17 Department of Public Works shall oversee the project described
18 herein.

19 **Section 3. Effective Date.** This ordinance shall become
20 effective upon signature by the Mayor or upon becoming effective
21 without the Mayor's signature.
