12 OVERSIGHT BY THE CULTURAL COUNCIL OF GREATER

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Appropriation.** For the 2024-2025 fiscal year,
17 within the City's budget, there are hereby appropriated the indicated
18 sum(s) from the account(s) listed in subsection (a) to the account(s)

30 for maintenance costs associated with the artwork entitled
31 "Calling it Done" located in Lift Ev'ry Voice and Sing Park

1 (the "Public Art").

2 **Section 3. Purpose.** The purpose of the appropriation in
3 Section 2 above is to allocate the \$24,200 in funds received in
4 connection with the donation of the Public Art to the City to provide
5 funding to the Art in Public Places Trust Fund for maintenance of the
6 Public Art as required by Section 118.614, Ordinance Code.

7 **Section 4. Oversight.** The Cultural Council of Greater
8 Jacksonville, Inc. shall be responsible for the maintenance of the
9 Public Art consistent with Section 118.618(d), Ordinance Code.

10 **Section 5. Effective Date.** This ordinance shall become
11 effective upon signature by the Mayor or upon becoming effective
12 without the Mayor's signature.
