AN ORDINANCE APPROVING THE SETTLEMENT OF JASON WEATHINGTON v. JACKSONVILLE SHERIFF'S OFFICE, CASE NO.: 20-020-D, PENDING BEFORE THE CITY OF JACKSONVILLE'S CIVIL SERVICE BOARD; AUTHORIZING THE MAYOR AND CORPORATION SECRETARY TO EXECUTE THE SETTLEMENT AGREEMENT; AUTHORIZING THE GENERAL COUNSEL, OR HIS DESIGNEE, TO TAKE FURTHER ACTION TO CONCLUDE THE MATTER; PROVIDING AN EFFECTIVE DATE.

WHEREAS, claimant, Jason Weathington ("Weathington"), was formerly employed from May 2004 to November 2020 by the Jacksonville Sheriff's Office ("JSO") as a police officer; and

WHEREAS, on June 3, 2019, JSO received information that Weathington had violated JSO policy and began an Internal Affairs investigation; and

WHEREAS, on March 17, 2020, JSO concluded the Internal Affairs investigation finding that Weathington had violated JSO policies and on May 15, 2020, JSO notified Weathington of his immediate suspension and pending termination for violation of JSO policies; and

WHEREAS, on May 15, 2020, Weathington appealed his termination and requested a hearing before the City of Jacksonville's Civil Service Board and on November 19, 2020, after a delay due to the Covid-19 pandemic, the Civil Service Board held a hearing and upheld Weathington's termination; and

WHEREAS, Weathington appealed the Civil Service Board's decision to the Circuit Court of the Fourth Judicial Circuit, in and

30 31 for Duval County (the "Circuit Court"), arguing that the Civil Service Rules required proof that Weathington's violation of JSO policy was intentional and no such proof was presented at the hearing; and

WHEREAS, on May 13, 2022, the Circuit Court agreed with Weathington and quashed the Civil Service Board's order; and

WHEREAS, the City and JSO challenged the Circuit Court's ruling by filing a petition for writ of certiorari with the Fifth District Court of Appeal, which was denied on June 5, 2023; and

WHEREAS, if the matter is reheard by the Civil Service Board, JSO would be required to prove that Weathington intentionally violated JSO policy; furthermore, and it is anticipated that JSO and Weathington would incur significant additional expenses and will face uncertain outcomes should this matter be reheard, which the parties wish to avoid; and

WHEREAS, if Weathington's termination is not upheld at a rehearing, Weathington would be reinstated as a police officer and would be entitled to full back pay dating back to May 15, 2020; and

WHEREAS, JSO and Weathington, through their respective representatives, engaged in settlement discussions and have reached a potential agreement, contingent on the approval and ratification by the City Council pursuant to the requirements of Chapter 112, Ordinance Code; and

WHEREAS, the Council finds that it is in the best interests of the City and the public that the Weathington civil service matter be resolved without resort to further litigation, costs and expenses; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Approval and Ratification of Settlement Agreement. There is hereby approved and ratified the Settlement Agreement (the "Agreement") between the City and Jason Weathington in the form attached hereto as Exhibit 1 and incorporated herein by

this reference.

Section 2. Execution Authorized. The Mayor, or her designee, and the Corporation Secretary are hereby authorized to execute and deliver on behalf of the City the Settlement Agreement and all such other documents necessary or appropriate to effectuate the purposes of the Agreement and this Ordinance.

Section 3. Further Action Authorized. The General Counsel, or his designee, is authorized to take such further action and to execute all other documents necessary to effectuate the approved and ratified Settlement Agreement.

Section 4. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
