PUBLIC HEARING INSTRUCTIONS – PARAPHRASED AND ADAPTED FOR LUZ (A COPY OF THE COUNCIL RULES FROM WHICH THESE ARE DERIVED IS AVAILABLE)

Rule 3.604 ADDRESSING THE COMMITTEE. Public Hearings - the LUZ Chair shall allow a reasonable number of proponents and opponents of the bill to be heard, including those who filed written requests to be heard. Each person when called shall proceed to the speaker podium, give their name, and also give their address unless they have already turned in a speaker card with their address on it. The time limit is three minutes unless the LUZ Chair changes it. All remarks shall be addressed to the Committee as a body. Any question you have for the Committee shall be directed through the LUZ Chair. No person other than a Council Member or the person at the podium shall enter into any discussion without the permission of the LUZ Chair.

RULE 4.505 DISRUPTION OF MEETING No member of the audience shall applaud nor make any noise or remarks that are audible to the Committee that would indicate approval or disapproval of anything being discussed. Any disregard of this rule may result in removal by the Sergeant-at-Arms.
