7 **ORDINANCE 2022-**

8 AN ORDINANCE CONCERNING AN APPLICATION FOR  
9 ASSIGNMENT AND TRANSFER OF RESIDENTIAL WASTE AND  
10 RECYCLING COLLECTION AND TRANSPORTATION  
11 SERVICES CONTRACT FOR SERVICE AREA I (CITY  
12 COUNCIL DISTRICTS 8, 7, 9, 10, 12, AND 14);  
13 DESIGNATING AND DIRECTING THE TRANSPORTATION,  
14 ENERGY & UTILITIES (TEU) COMMITTEE TO HOLD A  
15 NOTICED PUBLIC HEARING TO REVIEW AND MAKE  
16 RECOMMENDATIONS REGARDING APPROVAL OR  
17 DISAPPROVAL OF WASTE MANAGEMENT INC. OF FLORIDA,  
18 A FLORIDA CORPORATION AND SUCCESSOR BY MERGER TO  
19 ADVANCED DISPOSAL SERVICES JACKSONVILLE, LLC  
20 ("APPLICANT"), APPLICATION FOR ASSIGNMENT AND  
21 TRANSFER OF THE AMENDED AND RESTATED AGREEMENT  
22 FOR RESIDENTIAL WASTE AND RECYCLING COLLECTION  
23 AND TRANSPORTATION SERVICES (CONTRACT NO. 9165)  
24 BETWEEN THE CITY OF JACKSONVILLE ("CITY") AND  
25 ADVANCED DISPOSAL SERVICES JACKSONVILLE, LLC, IN  
26 ACCORDANCE WITH SECTION 382.308 (CONTRACT  
27 PROVISIONS; EXEMPTIONSEXEMPTION FROM PURCHASING  
28 CODE; EXTENSION OF CONTRACTS), PART 3 (SELECTION  
29 OF WASTE COLLECTION AND DISPOSAL SERVICE AREAS  
30 AND CONTRACTORS), CHAPTER 382 (WASTE COLLECTION  
31 AND DISPOSAL SERVICE BY CONTRACTORS AND CITY),

1           ORDINANCE CODE; DIRECTING THE CITY COUNCIL  
2           LEGISLATIVE SERVICES DIVISION TO ISSUE THE  
3           REQUIRED PUBLIC HEARING NOTICE IN ACCORDANCE  
4           WITH SECTION 382.308 (CONTRACT PROVISIONS;  
5           EXEMPTIONSEXEMPTION FROM PURCHASING CODE;  
6           EXTENSION OF CONTRACTS), PART 3 (SELECTION OF  
7           WASTE COLLECTION AND DISPOSAL SERVICE AREAS AND  
8           CONTRACTORS), CHAPTER 382 (WASTE COLLECTION AND  
9           DISPOSAL SERVICE BY CONTRACTORS AND CITY),  
10          ORDINANCE CODE; ADOPTING RECOMMENDED FINDINGS  
11          AND CONCLUSIONS OF THE TEU COMMITTEE;  
12          AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND  
13          CORPORATION SECRETARY TO EXECUTE AND DELIVER ANY  
14          NECESSARY CONTRACT DOCUMENTS TO EFFECTUATE THE  
15          TEU COMMITTEE RECOMMENDATIONS; PROVIDING AN  
16          EFFECTIVE DATE.

18          **WHEREAS**, the City and Advanced Disposal Services Jacksonville,  
19          LLC ("Advanced Disposal") entered into that certain Amended and  
20          Restated Agreement for Residential Waste and Recycling Collection and  
21          Transportation Services between the City of Jacksonville ("City") and  
22          Advanced Disposal Services Jacksonville, LLC ("ADS"), dated October  
23          23, 2015 (the "Amended and Restated Agreement") contained Revised On  
24          **File** and incorporated herein by this reference; and

25          **WHEREAS**, pursuant to the letter dated October 1, 2021, from  
26          Waste Management Inc. of Florida, a Florida corporation ("Waste  
27          Management") contained Revised On File ADS was merged with Waste  
28          Management, effective December 31, 2021; and

29          **WHEREAS**, as of December 31, 2021, the Amended and Restated  
30          Agreement, pursuant to the corporate merger and by operation of law,  
31          was assigned and transferred to Waste Management as successor in

1 interest to ADS;

2       **WHEREAS**, pursuant to Section 382.308 of the Ordinance Code and  
3 the terms of the Amended and Restated Agreement, the City must approve  
4 or disapprove of the assignment and transfer of the Amended and  
5 Restated Agreement to Waste Management; now therefore

6       **BE IT ORDAINED** by the Council of the City of Jacksonville:

7       **Section 1. Recitals.** The recitals above are incorporated  
8 herein by reference.

9       **Section 2. Designation of Council Committee to Review and**  
10 **Make Recommendations Regarding Waste Management's Assignment and**  
11 **Transfer Application.** Pursuant to Council Rule 2.102(a)(3), the TEU  
12 Committee is the Council standing committee to which matters on refuse  
13 and landfill are referred, and as such will act as the designated  
14 committee pursuant to Section 382.308(b), *Ordinance Code*. The TEU  
15 Committee shall hold a public hearing to review Waste Management's  
16 Assignment and Transfer Application attached hereto as **Exhibit 1** (the  
17 "Application") regarding the Amended and Restated Agreement in  
18 accordance with Section 382.308(b), *Ordinance Code*. The Application  
19 shall be in the form required in Sections 382.304 and 382.305,  
20 *Ordinance Code*. In accordance with Section 382.308(b), the TEU  
21 Committee shall review the Application and make a recommendation to  
22 the Council to approve or disapprove the application, with any  
23 conditions as deemed appropriate by the TEU Committee. The TEU  
24 Committee in recommending approval or disapproval of the Application  
25 to the Council shall consider the following criteria: (1) Applicant's  
26 financial fitness; (2) Applicant's experience; (3) the quality and  
27 quantity of the Applicant's equipment and facilities and the service  
28 to be rendered; (4) if the Applicant presently provides residential  
29 or commercial waste collection services, whether existing operations  
30 are satisfactory; (5) whether the Applicant or any of its owners,  
31 officers or directors has a criminal record; (6) the ability of the

1 Applicant to earn a fair return on invested capital; and (7) other  
2 considerations as the Committee deems relevant, except that the TEU  
3 Committee shall not consider rates of compensation or adjustment of  
4 service areas as provided in Section 382.307. If the Application is  
5 approved by the Council, the Applicant shall execute the appropriate  
6 assumption documents with the City in accordance with Section 382.308,  
7 *Ordinance Code*.

8       **Section 3.       Directing the Legislative Services Division to**  
9 **issue the Required Public Hearing Notice.** The Legislative Services  
10 Division is hereby directed to issue the required public hearing  
11 notice in accordance with Section 382.308, *Ordinance Code*, which  
12 requires that the Council give fifteen days' prior public notice by  
13 publication one time in a newspaper of general circulation in the  
14 City, of a public hearing to be held by the TEU Committee for the  
15 purpose of recommending approval or disapproval of the Application.  
16 The City Council public hearing date in accordance with Chapter 166,  
17 *Florida Statutes*, shall be on March 8, 2022, and the TEU Committee  
18 public hearing date in accordance with Section 382.308, *Ordinance*  
19 *Code*, shall be on March 14, 2022.

20       **Section 4.       Adoption of recommended findings, conclusions,**  
21 **and recommendations.** The Council has reviewed the TEU Committee's  
22 findings, conclusions, and recommendations regarding the Application.  
23 The TEU Committee's findings, conclusions, and recommendations  
24 regarding the Application are hereby adopted by the Council. This  
25 ordinance is the final action of the Council regarding the  
26 Application.

27       **Section 5.       Authorization.** The Mayor, or his designee, and  
28 Corporation Secretary are hereby authorized to execute and deliver  
29 for and on behalf of the City any contract documents necessary to  
30 effectuate the TEU Committee's recommendations regarding the  
31 Application.

1           **Section 6.           Effective Date.**   This ordinance shall become  
2 effective upon signature by the Mayor or upon becoming effective  
3 without the Mayor's signature.
