The map shall show all locations of schools, churches and adult entertainment facilities within a radius of 1,500 feet of the proposed location and the actual distances thereto from the proposed location measured as required by this Part. The map shall include a certificate that all distance requirements of this Part as relates to the proposed location have been met and both the map and certificate shall be prepared and executed by a land surveyor registered by the state.
