SCOPE OF SERVICES AND HOURLY RATE

- Review of Negotiated Agreement between City of Jacksonville and Jacksonville Jaguars with respect to the new Stadium and ancillary facilities.
- Advise the City Council on all aspects of the Negotiated Agreement between the City of Jacksonville and Jacksonville Jaguars.
- Submit information and reports to the Council President on an as-requested basis related to the foregoing.

The Downtown Investment Authority ("DIA") has filed legislation to appropriate additional FY 22/23 Northbank CRA Revenue available as of April 2023. The total amount is \$3,714,053.79.

This total amount includes funds received from the following Activities: Iguana Purchase of Shipyards Office parcel, \$3,209,498.08; Iguana Investment (Right of first offer) \$50,000; Fidelity National/Property Sale -Cypress, \$10; NB Courthouse Garage Tenant Lease Revenue \$40,282.26; NB Adams St Garage Revenue from Reef Parking, \$67,158.27; NB Sports Complex Garage from Reef Parking \$347,105.18. The revenue received from the operation of the Reef managed garages has outperformed our budget projections and is expected to continue to do so for the remainder of the year.

This legislation will appropriate all the funds to the Northbank Shipyards West CRA Project as approved by the DIA board in May per Res. 2023-05-02. This project is adjacent to the City CIP funded Shipyards West Park. The CRA portion will include parking with a food hall above, and a separate restaurant site on Hogan's Creek. Both facilities support and help to activate the adjacent park.

SALEM AMENDMENT

Council Member Salem offers the following amendment to File No. 2023-386:

- (1) On page 1, lines 9-10, strike "REQUESTING ONE CYCLE EMERGENCY PASSAGE;" and insert "PROVIDING FOR CARRYOVER OF FUNDS TO FISCAL YEAR 2023-2024; PROVIDING FOR REVERTER OF FUNDS; INVOKING THE EXEMPTION IN SECTION 126.107(G) (EXEMPTIONS), PART 1 (GENERAL REGULATIONS), CHAPTER 126 (PROCUREMENT CODE), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH MICHAEL HUYGHUE & ASSOCIATES, LLC; APPROVING AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER A CONTRACT WITH MICHAEL HUYGHUE & ASSOCIATES, LLC, FOR THE PROVISION OF CONSULTING SERVICES TO THE CITY COUNCIL RELATIVE TO CERTAIN ECONOMIC DEVELOPMENT PROJECTS; PROVIDING FOR OVERSIGHT BY THE OFFICE OF GENERAL COUNSEL;";
- (2) On page 1, line 29, strike "of economic development" and insert "regarding a proposed agreement between the City and Jax Jaguars, LLC, for development or redevelopment of a football stadium and ancillary facilities in Jacksonville as more specifically described herein";
- (3) On page 2, lines 4-10, strike all lines in their entirety and insert a new Section 3, Section 4, Section 5, Section 6, and Section 7 to read as follows:
 - "Section 3. Carryover. The funds appropriated by this Ordinance shall not lapse but shall carryover to fiscal year 2023-2024.
 - Section 4. Reverter. Any funds not utilized for the

purposes set forth in this Ordinance shall be returned to the account of origin by September 30, 2024.

Section 5. Invoking the Exemption in Section 126.107(g), Ordinance Code. The City is hereby authorized to procure the use of the professional services of Michael Huyqhue & Associates, LLC, to provide consulting services to the City Council on matters relative to a proposed agreement between the City and Jax Jaquars, LLC, for development or redevelopment a stadium and ancillary facilities in Jacksonville. Pursuant to Section 126.107(g) (Exemptions), Part 1 (General Regulations), Chapter 126 (Procurement Code), Ordinance Code, such procurement is exempt from competitive solicitation because the supplies or services are to be provided by those specifically prescribed within authorizing legislation that appropriates the same. With the exception of the foregoing, all other provisions of Chapter 126, Ordinance Code, shall remain in full force and effect.

Agreement Between the City and Michael Huyghue & Associates,
LLC. The Mayor, or her designee, and the Corporation Secretary
are hereby authorized to execute and deliver on behalf of the
City an agreement with Michael Huyghue & Associates, LLC, in
an amount not-to-exceed \$150,000, subject to the Scope of
Services and hourly rate more particularly described in Exhibit
2, for a term commencing upon the City's execution of the
agreement through September 30, 2024, and all other contracts
and documents, including extensions, renewals and amendments
to the agreement, and to otherwise take all action necessary

to effectuate the intent of this Ordinance, subject to appropriate legal review and approval by the Office of General Counsel and the City's Risk Management Division for appropriate insurance and indemnification requirements in accordance with Section 128.601, Ordinance Code.

Section 7. Oversight. The Office of General Counsel shall oversee the agreement described herein.";

- (4) Renumber the remaining Section accordingly;
- (5) On page 1, line 1, amend the introductory sentence to add that the bill was amended as reflected herein.
