History

- ➤ 1983: City Council expressed intent to adopt local option gas tax (LOGT) for 5 years (83-499-179)
- ➤ 1985: City Council levied \$0.06 LOGT for 10 years effective 9/1/86 (85-793-824)
- ➤ 1991: City Council extended the LOGT to the maximum 30 years expiration 8/31/16 (1991-819-411)
- ➤ 2000: City adopted the Better Jacksonville Plan and appropriated proceeds of LOGT to the JTA (2000-671-E; 2003-512-A; 2005-898-E)

Basis



- Interlocal Agreement between City of Jacksonville and JTA (2013-820-E)
 - Executed 7/29/14
 - Effective 9/1/16
- >\$0.01 to City and \$0.05 to JTA
- ightharpoonup Term = 20 years (2016 2036)
- ➤ Approved by Jacksonville City Council and JTA Board of Directors



Expenditures

- Development, construction, operation and/or maintenance of...roadway projects managed by JTA
- Any legal purpose
- Priority must be given to repayment of debt service



JTAMobilityWorks

- > 13 roadway projects; 14 mobility corridors
- > JTA issued \$100.55M revenue bonds in 2015
- Status of projects and funding reviewed quarterly in FACPAC meeting


