Dear Dr. Brown.

I am writing to tell you about my personal experience as a healthcare worker in Jacksonville during Covid-19. I urge you to cease the re-opening of Jacksonville as it is doing serious damage to the physical and mental health of our citizens.

I am a manager at an assisted living facility for adults with disabilities. My job is to ensure the safety and wellbeing of 19 adults with disabilities at L'Arche Jacksonville, many who are elderly with multiple illnesses

and extremely vulnerable to Covid-19. We began lockdown precautions in March and we have not lifted any stay-at-home protocols. This means our people with disabilities haven't seen their families in over three months. They typically attend day programs for enrichment purposes and now they cannot go to their day programs. They are stuck at home as all citizens were - but it is much worse for them. None of them have the skills to communicate via smartphone or tablet. They are so limited in their communication with the outside world that they are increasingly lonely and depressed. They can use a house phone to call families, but they need assistance to do so, and staff is so busy attending to the safety protocols that we have little time to help them call loved ones. They are suffering. It is heartbreaking for staff to continually tell them "just a little longer!" when Covid-19 rates are skyrocketing and it could be many more months until they can visit their families. The current state of re-opening also leaves our 40+ staff members confused and scared. I instructed my staff to ignore re-opening procedures because we cannot pretend our lives are back to "normal." Our responsibility is to protect our people with disabilities and they are locked down at home, so if Covid-19 entered the facility, it would almost certainly come from an infected staff member.

For me, this means I cannot see my partner or go back to my home because he is a nurse. I am living at the assisted living facility indefinitely. My partner could easily contract Covid-19 which would expose myself and the people for whom I am responsible. I am exhausted, burned out, and angry, especially now that there is no end in sight. Since I am living at work, I do not get a break. I am always at work, never able to return to my family to decompress from the stress of providing healthcare.

The decision to re-open Jacksonville shows people like me that you don't care about us or vulnerable populations. We have to be increasingly vigilant after several months of lockdown and we cannot take it anymore. I urge you to think about the people who suffer the most. We need to know we can trust your guidance, because right now, we are on our own. Sincerely,

What transactions with the federal government is the person or entity involved with?* In late April 2020, the United States Department of Treasury provided payment of \$169M to the City of Jacksonville through the CARES Act Relief Fund.

What is the nature of the complaint?*

The City of Jacksonville's local government misused Federal CARES Act Relief Grant funds by allocating the monies to a program that falls outside of the grant's funding guidelines. Three of the guidlines the program violates are listed below:

1. The Coronavirus Relief Fund Local Government Guidance Form (Page 2, Paragraph 2) states the funds can cover "costs incurred during the period that begins on March 1, 2020, and ends on December 30, 2020."
