A part of Farm 5, Dixie Farms, as recorded in Plat Book 7, page 12 of the current public records of Duval County, Florida, and being more particularly described as follows: For a point of reference commence at the Southeasterly comer of those lands described as Parcel "C" in Official Records Volume 3236, page 759 of said public records; thence South 31 degrees 33 minutes 30 seconds East, along the Westerly right of way line of Chester A venue ( a 50 foot right of way as now established), a distance of 353.30 feet to the Point of Beginning; thence continue South 31 degrees 33 minutes 30 seconds East, along said right of way line, a distance of 35.00 feet; thence South 58 degrees 26 minutes 30 seconds West, a
distance of 130.00 feet; thence South 31 degrees 33 minutes 30 seconds East, a distance of 129.85 feet to a point; said point lying on the Northerly line of Bowden park, as recorded in Plat Book 9, page 11; thence North 87 degrees 12 minutes 10 seconds West, along said North line of said Bowden Park, a distance of 144.15 feet to a point, said point being the Southeasterly corner of those lands described in Deed Book 935, page 175; thence North 31 degrees 33 minutes 30 seconds West, along the East line of said lands, a distance of 83.51 feet; thence North 58 degrees 26 minutes 30 seconds East, a distance of 249.00 feet to the point of beginning.
