4 **ORDINANCE 2021-850**

5 AN ORDINANCE APPROVING, AND AUTHORIZING THE MAYOR,
6 OR HIS DESIGNEE, AND CORPORATION SECRETARY TO
7 EXECUTE AND DELIVER THE FIRST AMENDMENT TO
8 INTERLOCAL AGREEMENT REGARDING VETERANS' SUICIDE
9 PREVENTION BY AND AMONG THE CITY OF JACKSONVILLE,
10 DUVAL COUNTY ("CITY"), AND THE COUNTIES OF BAKER,
11 CLAY, NASSAU, AND ST. JOHNS ("INTERLOCAL
12 AGREEMENT"), TO REMOVE THE CITY AS THE
13 ADMINISTRATOR FOR THE FIRE WATCH COUNCIL OF
14 NORTHEAST FLORIDA; PROVIDING FOR CONTINGENCY;
15 PROVIDING AN EFFECTIVE DATE.

17 **WHEREAS**, the Counties of Baker, Clay, Nassau and St. Johns and
18 the City of Jacksonville, Duval County ("City") (collectively, the
19 "Counties" or individually, "County") previously entered into that
20 certain Interlocal Agreement Regarding Veterans' Suicide Prevention
21 ("Interlocal Agreement"), which established the Counties as members
22 of the Northeast Florida Fire Watch Council (the "Fire Watch
23 Council"), as authorized by City of Jacksonville Ordinance 2019-701-
24 E; and

25 **WHEREAS**, the Interlocal Agreement identified the City as the
26 Administrator for the Fire Watch Council to assist the Fire Watch
27 Council with administrative matters as described in the Interlocal
28 Agreement; and

29 **WHEREAS**, the City's services as the Administrator are no longer
30 needed, and the Fire Watch Council has requested that the Interlocal
31 Agreement be amended to remove the City as the Administrator; and

1 **WHEREAS**, the City and the Fire Watch Council desire to amend the
2 Interlocal Agreement to effectuate this change; now therefore
3 **BE IT ORDAINED** by the Council of the City of Jacksonville:

4 **Section 1. Recitals.** The Recitals above are true and
5 correct and incorporated herein by this reference.

6 **Section 2. Approval and authorizations.** There is hereby
7 approved, and the Mayor, or his designee, and Corporation Secretary
8 are hereby authorized to execute and deliver for and on behalf of the
9 City the First Amendment to Interlocal Agreement Regarding Veterans'
10 Suicide Prevention ("First Amendment") in substantially the same form
11 as is attached hereto and incorporated herein by this reference as
12 **Exhibit 1.**

13 **Section 3. Contingency.** This ordinance is conditioned upon
14 the participating Counties and the City of Jacksonville executing the
15 First Amendment.

16 **Section 4. Effective Date.** This ordinance shall become
17 effective upon signature by the Mayor or upon becoming effective
18 without the Mayor's signature.
