AN ORDINANCE REGARDING CHAPTER 745 (ADDRESSING AND STREET NAMING REGULATIONS) ORDINANCE CODE; ESTABLISHING AN HONORARY STREET DESIGNATION AND ASSOCIATED ROADWAY MARKERS FOR LIEUTENANT MARIO J. MOYA, A FALLEN FIRE AND RESCUE OFFICER WHO DIED WHILE IN THE LINE OF DUTY; ESTABLISHING AN HONORARY STREET DESIGNATION ON RICKY DRIVE IN COUNCIL DISTRICT 6 FOR LIEUTENANT MARIO J. MOYA; PROVIDING FOR THE ROADSIDE MARKERS FOR LIEUTENANT MARIO J. MOYA BE DEPICTED AS CONTEMPLATED IN SECTION 745.105 (J) (9) (B); PROVIDING FOR THE INSTALLATION OF TWO HONORARY ROADWAY MARKERS TO BE LOCATED APPROPRIATE LOCATIONS ON THE DESIGNATED ROADWAY IN COUNCIL DISTRICT 6; WAIVER OF SECTION 745.105 (I) (2) WHICH REQUIRES THAT THE HONOREE BE DECEASED FOR AT LEAST 5 YEARS; WAIVER OF SECTION 745.105 (J)(10), ORD. CODE WHICH REQUIRES THAT THE PLANNING AND DEVELOPMENT DEPARTMENT SEND TWO WRITTEN NOTIFICATIONS TO AFFECTED PROPERTY OWNERS; DIRECTING THE LEGISLATIVE SERVICES DIVISION TO FORWARD THIS ORDINANCE TO THE PLANNING AND DEVELOPMENT DEPARTMENT PROCESSING, IMPLEMENTATION, AND COORDINATION THE PUBLIC WORKS DEPARTMENT, TRAFFIC ENGINEERING AND OTHER AFFECTED AGENCIES AND

WHEREAS, the Jacksonville Fire and Rescue Department (JFRD) submitted a request for an Honorary Street Name Designation to honor Fire and Rescue Lieutenant Mario J. Moya; (Correspondence from the Office of the Director/Fire Chief, City of Jacksonville Fire and Rescue Department is attached hereto as Exhibit 1); and

WHEREAS, Section 745.105 (j)(9)(b), Ord. Code, provides for honorary designations for fallen fire and rescue officers who die while in the Line of Duty; and

WHEREAS, in accordance with the criteria established pursuant to Florida law, Lieutenant Mario J. Moya died while in the Line of Duty; (The Florida Joint Council of Fire and Emergency Services Firefighter Line-of-Duty Death Memorial Selection Process is attached hereto as Exhibit 2); and

WHEREAS, Lt. Moya dedicated 17 years to the JFRD assigned as a Firefighter to Rescue 42 on the B-shift, and was promoted up the ranks to a Lieutenant position; and

WHEREAS, the Florida Joint Council of Fire and Emergency Services will honor Lt. Moya's name on the Memorial Wall at the Florida Fallen Firefighter Memorial in Ocala, Florida, and at the State Capitol; (See attached Exhibit 2); and

WHEREAS, there will be additional events to recognize the memory of Lt. Moya which include a "Ringing of the Bell" ceremony, a "Last Guard" ritual, presentation of a fallen firefighter memorial flag and a medallion; and

WHEREAS, the Council finds that the accomplishments of Lieutenant Mario J. Moya are worthy and deserving of a form of recognition that the City of Jacksonville and Lieutenant Mario J. Moya's family, friends and colleagues can share and celebrate in, to wit: the creation of an honorary street designation and the

installation of two appropriate honorary roadway markers on Ricky Drive in Council District 6; now therefore,

WHEREAS, pursuant to Section 745.105(i)(3), Ord. Code, the honoree lived in excess of 10 years in the community located within 5 miles of the location for the honorary designation; and

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Ricky Drive to receive an honorary street designation for Lieutenant Mario J. Moya. Ricky Drive in Council District 6 shall hereby be designated as contemplated by Section 745.105, Ordinance Code, for Lieutenant Mario J. Moya. A map of the road designation is attached hereto as Exhibit 3.

J. Moya to be depicted as authorized in Section 745.105 (j) (9) (a)-(b), Ord. Code. Two honorary roadside markers shall depict the appropriate badge and/or emblem color for Lieutenant Mario J. Moya as contemplated in Section 745.105 (j) (9) (a)-(b), Ordinance Code, to read as follows:

Fire and Rescue Officer Lieutenant Mario J. Moya

End of Watch

August 17, 2021

J. Moya to be installed. Two honorary roadside markers, as contemplated by Section 745.105, Ordinance Code, recognizing and honoring Lieutenant Mario J. Moya shall be placed in appropriate locations at the intersection of San Jose Blvd and Ricky Drive and in front of Fire Station 42 located at 2948 Delor Drive, Jacksonville.

Section 4. Waiver of Section 745.105(i)(2), Ord. Code. Section 745.105(i)(2), Ord. Code which requires that the honoree be deceased for a least five years is hereby waived due to the fact that the honoree died while in the Line of Duty.

Waiver of Section 745.105(j)(10), Ord. Code. Section 5. Section 745.105(j)(10), Ord. Code which requires that the Planning and Development Department send two written notifications to affected property owners is hereby waived because no property owners are addressed from or affected by the designated portion of Ricky Drive.

Section 6. Directing Legislative Services to forward a copy to the Planning and Development Department. The Chief of Legislative Services is requested to send a copy of this legislation, once enacted, to the Planning and Development Department, Addressing Unit, for processing, implementation, and coordination with the Public Works Department, Traffic Engineering Division and other affected agencies and organizations.

Effective Date. This ordinance shall become Section 7. effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
