5 AN ORDINANCE APPROPRIATING \$376,846.00 IN GRANT  
6 FUNDING FROM THE U.S. DEPARTMENT OF JUSTICE,  
7 BUREAU OF JUSTICE ASSISTANCE, EDWARD BYRNE  
8 MEMORIAL JUSTICE ASSISTANCE PROGRAM, TO FUND  
9 VARIOUS PROGRAMS AND ACTIVITIES AIMED AT CRIME  
10 CONTROL AND PREVENTION, IMPROVING THE CRIMINAL  
11 JUSTICE SYSTEM, AND IMPROVING PUBLIC SAFETY IN  
12 DUVAL COUNTY, AS INITIATED BY B.T. 22-016;  
13 PURPOSE OF APPROPRIATION; PROVIDING FOR A  
14 CARRYOVER OF FUNDS INTO FISCAL YEAR 2022-2023;  
15 AUTHORIZING POSITIONS, AS INITIATED BY R.C. 22-  
16 005; PROVIDING FOR OVERSIGHT BY THE FINANCE AND  
17 ADMINISTRATION DEPARTMENT, OFFICE OF GRANT AND  
18 CONTRACT COMPLIANCE; PROVIDING FOR AN EFFECTIVE  
19 DATE.

21 **BE IT ORDAINED** by the Council of the City of Jacksonville:

22 **Section 1. Appropriation.** For the 2021-2022 fiscal year,  
23 within the City's budget, there is hereby appropriated the indicated  
24 sum from the account(s) listed in subsection (a) to the account(s)  
25 listed in subsection (b):

1 (c) Explanation of Appropriation:

2 The funding above is a grant from the U.S. Department of  
3 Justice ("DOJ"), Bureau of Justice Assistance, Edward Byrne  
4 Memorial Justice Assistance Grant Program to support  
5 various programs and activities aimed at crime control and  
6 prevention, improving the criminal justice system, and  
7 improving public safety in Duval County. The grant period  
8 commenced on October 1, 2019 and continues through  
9 September 30, 2023. No local match is required.

10 **Section 2. Purpose.** The purpose of the appropriation in

11 Section 1 is to provide funding for various programs and activities  
12 aimed at preventing and controlling crime, improving the criminal  
13 justice system, and improving public safety throughout Duval County.  
14 A portion of these funds will be used to support the City's DAWN  
15 (Developing Adults With Necessary Skills) and InVEST programs. The  
16 DAWN program provides General Education Development (GED) and adult  
17 basic education instruction, life skills and job training, and  
18 transitional counseling classes to adults aged 18 and over who are  
19 incarcerated in Jacksonville Sheriff's Office facilities. The InVEST  
20 program involves a collaborative effort between the City's Victim  
21 Services Center, the Jacksonville Sheriff's Office, and Hubbard  
22 House, Inc. to assist victims of domestic violence. In addition, the  
23 grant funds will be used to support the creation of a Community Crime  
24 Strategies Unit that will work in coordination with the Fourth  
25 Judicial Circuit State Attorney's Office to develop a community-based  
26 presence that seeks to solve crime-related problems and to empower  
27 the community. Finally, as required pursuant to the conditions of  
28 the grant, three percent (3%) of the grant funds awarded (\$11,305.00)  
29 will be used to offset the costs for contractual services to complete  
30 analyses, gather and map out data processes, and build the reports  
31 required for compliance with the DOJ's National Incident Based

1 Reporting System data submission requirements.

2 A copy of the Grant Award from the U.S. Department of Justice  
3 dated September 19, 2020 (Award No. 2020-DJ-BX-0866) is **On File** with  
4 the City Council Legislative Services Division.

5 **Section 3. Carryover.** The funds appropriated in this  
6 Ordinance shall not lapse but shall carryover to fiscal year 2022-  
7 2023.

8 **Section 4. Approval of Positions.** There are hereby  
9 approved the positions more fully described in R.C. 22-005, attached  
10 hereto as **Exhibit 2** and incorporated herein by this reference.

11 **Section 5. Oversight Department.** The Finance and  
12 Administration Department, Office of Grant and Contract Compliance,  
13 shall oversee the grant and positions described herein.

14 **Section 6. Effective Date.** This Ordinance shall become  
15 effective upon signature by the Mayor or upon becoming effective  
16 without the Mayor's signature.
