ORDINANCE 2021-813-E

AN ORDINANCE REZONING APPROXIMATELY 8.78± ACRES, LOCATED IN COUNCIL DISTRICT 11 AT 0 BAYMEADOWS ROAD (R.E. NO. 167746-0260), BETWEEN INTERSTATE-295 AND R.G. SKINNER PARKWAY, AS DESCRIBED HEREIN, OWNED BY PINNACLE RENTAL COMMUNITY LLC, FROM PLANNED UNIT DEVELOPMENT (PUD) DISTRICT (2002-928-E) TO PLANNED UNIT DEVELOPMENT (PUD) DISTRICT, AS DEFINED AND CLASSIFIED UNDER THE ZONING CODE, TO PERMIT MULTI-FAMILY RESIDENTIAL AND RECREATIONAL USES, AS DESCRIBED ΙN SKINNER/9A PUD; PUD SUBJECT TOCONDITION; PROVIDING A DISCLAIMER THAT THE REZONING GRANTED HEREIN SHALL NOT BE CONSTRUED AS AN EXEMPTION FROM ANY OTHER APPLICABLE LAWS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Pinnacle Rental Community LLC, the owner of approximately 8.78± acres, located in Council District 11 at 0 Baymeadows Road (R.E. No. 167746-0260), as more particularly described in Exhibit 1, dated October 19, 2021, and graphically depicted in Exhibit 2, both of which are attached hereto (the "Subject Property"), have applied for a rezoning and reclassification of that property from Planned Unit Development (PUD) District (2002-928-E) to Planned Unit Development (PUD) District, as described in Section 1 below; and

WHEREAS, the Planning Commission has considered the application and has rendered an advisory opinion; and

WHEREAS, the Land Use and Zoning Committee, after due notice and public hearing, has made its recommendation to the Council; and

WHEREAS, the Council finds that such rezoning is: (1) consistent with the 2030 Comprehensive Plan; (2) furthers the goals, objectives and policies of the 2030 Comprehensive Plan; and (3) is not in conflict with any portion of the City's land use regulations; and

WHEREAS, the Council finds the proposed rezoning does not adversely affect the orderly development of the City as embodied in the Zoning Code; will not adversely affect the health and safety of residents in the area; will not be detrimental to the natural environment or to the use or development of the adjacent properties in the general neighborhood; and will accomplish the objectives and meet the standards of Section 656.340 (Planned Unit Development) of the Zoning Code; now, therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Property Rezoned. The Subject Property is hereby rezoned and reclassified from Planned Unit Development (PUD) District (2002-928-E) to Planned Unit Development (PUD) District. This new PUD district shall generally permit multi-family residential and recreational uses, and is described, shown and subject to the following documents, attached hereto:

- Exhibit 1 Legal Description dated October 19, 2021.
- 23 Exhibit 2 Subject Property per P&DD.

- 24 Exhibit 3 Written Description dated October 25, 2021.
 - Exhibit 4 Site Plan dated October 8, 2021.
 - Section 2. Rezoning Approved Subject to Condition. This rezoning is approved subject to the following condition. Such condition controls over the Written Description and the Site Plan and may only be amended through a rezoning.
 - (1) A traffic study shall be provided with the Civil Site Plan Review. The traffic study shall address all of the items discussed

at the methodology meeting held on September 20, 2021 for this project.

Section 3. Owner and Description. The Subject Property is owned by Pinnacle Rental Community LLC, and is legally described in Exhibit 1, attached hereto. The applicant is T.R. Hainline, Esq., 1301 Riverplace Boulevard, Suite 1500, Jacksonville, Florida 32207; (904) 346-5531.

Section 4. Disclaimer. The rezoning granted herein shall <u>not</u> be construed as an exemption from any other applicable local, state, or federal laws, regulations, requirements, permits or approvals. All other applicable local, state or federal permits or approvals shall be obtained before commencement of the development or use and issuance of this rezoning is based upon acknowledgement, representation and confirmation made by the applicant(s), owner(s), developer(s) and/or any authorized agent(s) or designee(s) that the subject business, development and/or use will be operated in strict compliance with all laws. Issuance of this rezoning does <u>not</u> approve, promote or condone any practice or act that is prohibited or restricted by any federal, state or local laws.

Section 5. Effective Date. The enactment of this Ordinance shall be deemed to constitute a quasi-judicial action of the City Council and shall become effective upon signature by the Council President and the Council Secretary.
