ORDINANCE 2022-96-E

AN ORDINANCE AMENDING CHAPTER 250 (MISCELLANEOUS BUSINESS REGULATIONS) TO APPLY THE PROHIBITION ON SIMULATED GAMBLING DEVICES TO THE GENERAL SERVICES DISTRICT, LESS THE SECOND, THIRD, FOURTH AND FIFTH URBAN SERVICES DISTRICTS; REQUESTING EMERGENCY PASSAGE UPON INTRODUCTION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on May 28, 2019 the Council enacted 2019-209-E, which declared the use of simulated gambling devices for any commercial, promotional or pecuniary gain or purpose to be a public nuisance and prohibited their continued use in the City's First Urban Services District within six (6) months of the August 1, 2019 effective date; and

WHEREAS, on October 8, 2019, because of continued and ongoing criminal activities associated with these facilities (including robberies, murders and deaths), the Council enacted 2019-644-E to eliminate the public nuisance by immediately prohibiting the use of simulated gambling devices; and

WHEREAS, the Council intended the prohibition to apply to the entire City except in the cities of Atlantic Beach, Neptune Beach, Jacksonville Beach and the town of Baldwin instead of only in the First Urban Services District; and

WHEREAS, it is the Council's intent, through this legislation, to clarify this intent and correct the limitation in Section 250.1303,

Ordinance Code, regarding the area of enforcement for the prohibition on simulated gambling devices; now, therefore,

BE IT ORDAINED by the Council of the City of Jacksonville:

Amending Chapter 250 (Miscellaneous Business Section 1. Regulations), Ordinance Code to amend Part 13 (Prohibition of Simulated Gambling Devices), Section 250.1303. Chapter 250 (Miscellaneous Business Regulations), Part 13 (Prohibition Simulated Gambling Devices), Section 250.1303 (Area of enforcement), Ordinance Code is hereby amended to read as follows:

Chapter 250. Miscellaneous Business Regulations.

Part 13. Prohibition of Simulated Gambling Devices.

Sec. 250.1303. Area of enforcement.

The Council is acting herein as the governing body for the City of Jacksonville, and this Part shall be effective within the boundaries of the First Urban Services DistrictGeneral Services District, less Urban Services Districts 2, 3, 4 and 5.

Section 2. Requesting Emergency Passage Pursuant to Council Rule 4.901 Emergency. Emergency passage of this legislation upon introduction is requested. The nature of the emergency is to expedite the City's ability to pursue enforcement against public nuisance facilities currently operating in violation of the ordinance code and to clarify and fulfill the Council's original intent for City-wide enforcement, except for the cities of Atlantic Beach, Neptune Beach, Jacksonville Beach and the town of Baldwin.

Section 3. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
