5 AN ORDINANCE APPROPRIATING \$30,000.00 IN GRANT
6 FUNDING FROM THE FLORIDA FISH AND WILDLIFE
7 CONSERVATION COMMISSION (THE "FWC") FOR
8 REIMBURSEMENT OF THE CITY OF JACKSONVILLE'S
9 COSTS TO REMOVE TWO DERELICT VESSELS LOCATED IN
10 PUBLIC WATERWAYS IN THE CITY OF JACKSONVILLE, AS
11 INITIATED BY B.T. 22-031; PURPOSE OF
12 APPROPRIATION; PROVIDING FOR OVERSIGHT BY THE
13 NEIGHBORHOODS DEPARTMENT, ENVIRONMENTAL QUALITY
14 DIVISION; PROVIDING AN EFFECTIVE DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Appropriation.** For the 2021-2022 fiscal year,
18 within the City's budget, there are hereby appropriated the indicated
19 sum(s) from the account(s) listed in subsection (a) to the account(s)
20 listed in subsection (b):

22 this reference)

27 (c) Explanation of Appropriation:

28 The funding above represents an appropriation of \$30,000.00
29 in grant funding from the Florida Fish and Wildlife
30 Conservation Commission (the "FWC") for reimbursement to
31 the City of the costs to remove two derelict vessels

1 located in public waterways within the City.

2 **Section 2. Purpose.** The purpose of the appropriation in
3 Section 1 is to appropriate grant funding from the FWC to offset the
4 City's costs for removal of two derelict vessels located in public
5 waterways within the City. Pursuant to that certain State of Florida
6 Fish and Wildlife Conservation Commission Agreement No. 21191 (the
7 "Agreement"), the FWC will reimburse the City up to \$30,000.00 for
8 removal of one 27 foot vessel of unknown make/model located on the
9 south side of the channel on the northeast side of the SR17 bridge
10 and one 26 foot sailboat of unknown make/model located off the
11 intercoastal waterway near an abandoned property on the 600 block of
12 Atlantic Boulevard. Removal of these vessels must occur prior to
13 expiration of Agreement on April 29, 2022. Once removed, both vessels
14 will be disposed of in an authorized landfill facility. A copy of
15 the Agreement is **On File** with the Office of Legislative Services.

16 **Section 3. Oversight.** The Environmental Quality
17 Division of the Neighborhoods Department shall provide oversight of
18 the project described herein.

19 **Section 4. Effective Date.** This Ordinance shall become
20 effective upon signature by the Mayor or upon becoming effective
21 without the Mayor's signature.
