18 WHEREAS, the Florida Inland Navigation District (FIND) 19 solicits grant applications from counties within its jurisdiction to 20 undertake waterways-related projects; and

21 WHEREAS, FIND grant applications must be accompanied by 22 legislation acknowledging a county's willingness to meet the matching 23 funding requirements; and

WHEREAS, the Department of Parks, Recreation and Community Services has compiled and recommends several grant projects for submission to FIND; and

WHEREAS, the Jacksonville Waterways Commission approved the recommended projects at its meeting on November 10, 2021; now, therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Recitals. The recitals above are true and correct and incorporated herein by reference.

3 Approved Projects. The 2022 FIND grant projects Section 2. recommended by the Department of Parks, Recreation and Community 4 5 Services listed on **Exhibit 1**, attached hereto and incorporated herein by this reference (the "Projects"), are approved for submission to 6 7 the Florida Inland Navigation District for purposes of receiving such grants. The Projects are: Riverview Park Boat Ramp - Construction 8 9 (Council District 8); Liberty Street Marina - Design (Council District 10 7); Pottsburg Creek/Beach Boulevard Boat Ramp - Design (Council 11 District 4); Mike McCue Boat Ramp Bulkhead - Design (Council District 13); Oak Harbor Boat Ramp Bulkhead - Design (Council District 13); 12 and, Thomas Creek Fish Camp Kayak Launch - Design (Council District 13 14 7), as more particularly described in **Exhibit 2**, attached hereto and incorporated herein by this reference. These six grant applications 15 total \$3,795,000, \$1,725,000 reimbursable from FIND and \$2,070,000 16 17 from the City's match, including internal engineering fees.

18 Section 3. Authorization. The Mayor, for and on behalf of 19 the City, is authorized to apply for Florida Inland Navigation 20 District grants for the Projects.

21 Section 4. Execution authorized. The Mayor, or his 22 designee, and the Corporation Secretary are hereby authorized to 23 execute and deliver, for and on behalf of the City, all grant 24 agreements, including any grant agreement extensions, for the Projects between the City and FIND, as well as any and all documents 25 26 related to such grants.

27 Section 5. Acknowledging willingness to match funding. The 28 City of Jacksonville is willing to meet FIND's matching funding 29 requirements as they relate to the Projects described in **Exhibit 1**.
