## ORDINANCE 2022-95-E

ΑN ORDINANCE AUTHORIZING THE CTTY OF JACKSONVILLE TO JOIN WITH THE STATE OF FLORIDA OTHER LOCAL GOVERNMENTAL AND UNITS PARTICIPANT IN THE STATE'S SETTLEMENT WITH ENDO HEALTH SOLUTIONS, INC. AND ENDO PHARMACEUTICALS, REQUESTING **EMERGENCY** PASSAGE INTRODUCTION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Jacksonville has suffered harm from the opioid epidemic and further recognizes that the entire State of Florida has suffered harm from the opioid epidemic; and

WHEREAS, the State of Florida has filed an action pending in Pasco County, Florida, and a number of Florida Cities and Counties have also filed an action <u>In re: National Opiate Litigation</u>, MDL No. 2804 (N.D. Ohio) (the "Opioid Litigation") and the City of Jacksonville is a litigating participant in that action; and

WHEREAS, the State of Florida has entered into a settlement agreement with Defendants, Endo Health Solutions, Inc. and Endo Pharmaceuticals, Inc. ("Endo Settlement"); and

WHEREAS, the City of Jacksonville is a participant in the State of Florida's unified plan, known as the "Florida Plan," for the allocation and use of prospective settlement dollars from opioid related litigation, inclusive of the allocation and use of prospective settlement dollars from the Endo Settlement; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Purpose. The purpose of this Ordinance is to authorize the City of Jacksonville's participation in the Endo

Settlement as memorialized in the executed Settlement Agreement and Release attached hereto as Exhibit 1.

Authorization to Execute and Implement. Section 2. Council hereby approves, and the Mayor, or his designee, and the Corporation Secretary, are hereby authorized to execute, for and on behalf of the City of Jacksonville, the Subdivision Settlement Participation Form in substantially the form attached hereto as Exhibit 2, and to take, or cause to be taken, for and on behalf of the City, such further action as is necessary to effectuate the purpose of this Ordinance.

Section 3. Requesting Emergency Passage upon Introduction Pursuant to Council Rule 4.901 Emergency. Emergency passage upon introduction of this legislation is requested. The nature of the emergency is that the State of Florida has requested execution and return of the Subdivision Settlement Participation Form on or before February 15, 2022.

Effective Date. This Ordinance shall become Section 4. effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
