outlined herein (the "Grant"). The Grant period commenced on February 1, 2022 and continues through February 28, 2025. No local match is required.

Purpose. The purpose of the appropriation in Section 2. Section 1 is to provide funding for mental health, life skills coaching, and drug treatment and services for Teen Court program participants. The Grant helps to cover the gap in funding for these critical services. This is a three-year grant at \$35,000.00 per year for a total grant amount of \$105,000.00. A copy of the Grant Contract and Grant award letter is attached hereto as Exhibit 2.

Section 3. Carryover. The funds appropriated in this Ordinance shall not lapse but shall carryover to fiscal year 2024-2025.

Section 4. Oversight and Reporting. The Court Administration, Director of Teen Courts, shall provide oversight of the grant described herein. The Director of Teen Courts shall also be responsible to provide grant activity reports to the Community Foundation of Northeast Florida in accordance with the terms of the grant.

Section 5. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
