ORDINANCE 2022-158

AN ORDINANCE CLOSING AND ABANDONING AND/OR DISCLAIMING A PARTIALLY OPENED AND PARTIALLY IMPROVED PORTION OF THE CAMDEN ROAD RIGHT-OF-WAY, AS RECORDED IN PLAT BOOK 1, PAGES 7 AND 8 OF THE FORMER PUBLIC RECORDS OF DUVAL COUNTY, FLORIDA, IN COUNCIL DISTRICT 7, AT THE REQUEST OF THREE DAYS HOLDING COMPANY, LLC, SUBJECT TO RESERVATION UNTO JEA OF AN ALL UTILITIES, FACILITIES AND ACCESS EASEMENT AND RESERVATION UNTO THE CITY OF JACKSONVILLE OF A DRAINAGE EASEMENT; PROVIDING FOR APPROVAL SUBJECT TO CONDITIONS; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville: 18 19 Section 1. Closure and Abandonment. A partially opened and 20 partially improved portion of the Camden Road right-of-way, as 21 recorded in Plat Book 1, Pages 7 and 8 of the former public records 22 of Duval County, Florida, located in Council District 7, a depiction 23 and description of which is attached hereto as **Exhibit 1** and 24 incorporated herein by this reference, is hereby closed and abandoned 25 and/or disclaimed as a right-of-way at the request of Three Days Holding Company, LLC (the "Applicant"); provided however, there is 26 27 reserved unto JEA an all utilities, facilities and access easement 28 on, over, under, through and across the closed right-of-way for ingress and egress and for all utilities and facilities, including 29 30 but not limited to, water, sewer and electric, so as to provide JEA 31 continued access to repair and maintain these utilities and

1 facilities, and there is further reserved unto the City of 2 Jacksonville a drainage easement on, over, under, through and across 3 the right-of-way closure area.

Aviles-Robbins, LLC, the property owner abutting the closure area to the east, is affiliated with the Applicant and has paid the right-of-way closure application fee of \$2,091.00. This amount has been deposited into the General Fund. This closure request was reviewed and approved by the various city, state, and utility agencies that might have an interest in the right-of-way and there were no objections to the Applicant's request.

11 Section 2. Purpose. The Applicant owns property adjacent 12 to the closure area at 0 Camden Road (R.E. No. 109501-0000) and is 13 requesting the closure in order to secure the closure area to store 14 and maintain the Applicant's vehicles and those of other companies, 15 subject to the conditions set forth herein.

Section 3. Hold Harmless Covenant. The 16 closure and 17 abandonment by the City of its interests in the right-of-way is subject to Applicant's execution and delivery to the City of a Hold 18 19 Harmless Covenant, in substantially the same form attached hereto as Exhibit 2 and incorporated herein by this reference. Accordingly, 20 21 the closure and abandonment of the right-of-way shall not be recorded 22 in the public records until execution and delivery to the City by the 23 Applicant of the required Hold Harmless Covenant.

Section 4. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
