6 AN ORDINANCE APPROPRIATING GRANT FUNDS IN THE
7 AMOUNT OF \$105,000.00 FROM THE COMMUNITY
8 FOUNDATION FOR NORTHEAST FLORIDA TO PROVIDE
9 MENTAL HEALTH, LIFE SKILLS COACHING, AND DRUG
10 TREATMENT AND SERVICES FOR TEEN COURT PROGRAM
11 PARTICIPANTS, AS INITIATED BY B.T. 22-047;
12 PURPOSE OF APPROPRIATION; PROVIDING FOR
13 CARRYOVER OF FUNDS TO FISCAL YEAR 2024-2025;
14 PROVIDING FOR OVERSIGHT AND REPORTING BY THE
15 COURT ADMINISTRATION, DIRECTOR OF TEEN COURTS;
16 PROVIDING AN EFFECTIVE DATE.

18 **BE IT ORDAINED** by the Council of the City of Jacksonville:

19 **Section 1. Appropriation.** For the 2021-2022 fiscal year,
20 within the City's budget, there is hereby appropriated the indicated
21 sum(s) from the account(s) listed in subsection (a) to the account(s)
22 listed in subsection (b):

29 (c) Explanation of Appropriation

30 The funding above is an appropriation of grant funds from
31 the Community Foundation for Northeast Florida to provide

1 certain services to Teen Court program participants as
2 outlined herein (the "Grant"). The Grant period commenced
3 on February 1, 2022 and continues through February 28,
4 2025. No local match is required.

5 **Section 2. Purpose.** The purpose of the appropriation in
6 Section 1 is to provide funding for mental health, life skills
7 coaching, and drug treatment and services for Teen Court program
8 participants. The Grant helps to cover the gap in funding for these
9 critical services. This is a three-year grant at \$35,000.00 per year
10 for a total grant amount of \$105,000.00. A copy of the Grant Contract
11 and Grant award letter is attached hereto as **Exhibit 2**.

12 **Section 3. Carryover.** The funds appropriated in this
13 Ordinance shall not lapse but shall carryover to fiscal year 2024-
14 2025.

15 **Section 4. Oversight and Reporting.** The Court
16 Administration, Director of Teen Courts, shall provide oversight of
17 the grant described herein. The Director of Teen Courts shall also
18 be responsible to provide grant activity reports to the Community
19 Foundation for Northeast Florida in accordance with the terms of the
20 grant.

21 **Section 5. Effective Date.** This Ordinance shall become
22 effective upon signature by the Mayor or upon becoming effective
23 without the Mayor's signature.
