5 AN ORDINANCE AUTHORIZING THE CITY TO ENTER INTO  
6 A SECOND AMENDED AND RESTATED FUNDING AGREEMENT  
7 BETWEEN THE CITY OF JACKSONVILLE AND THE  
8 JACKSONVILLE TRANSPORTATION AUTHORITY ("JTA")  
9 TO EXTEND THE TERM OF AND EXPAND THE "DOOR-TO-  
10 STORE PROGRAM" APPROVED BY ORDINANCE 2021-46-E  
11 AND EXPANDED BY ORDINANCE 2021-140-E (THE  
12 "PROGRAM"), A COMPONENT OF THE FULL-SERVICE  
13 GROCERY STORE IMPROVEMENT PROGRAM ESTABLISHED  
14 UNDER ORDINANCE 2019-812-E; PROVIDING FOR CITY  
15 OVERSIGHT AND PROGRAM ADMINISTRATION BY THE  
16 OFFICE OF ECONOMIC DEVELOPMENT; PROVIDING AN  
17 EFFECTIVE DATE.

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Approval and authorization for the Amended and**  
21 **Restated Funding Agreement.** There is hereby approved, and the  
22 Mayor, or his designee, and the Corporation Secretary are hereby  
23 authorized to execute and deliver, for and on behalf of the City,  
24 that certain Second Amended and Restated Funding Agreement (the  
25 "Agreement") between the City of Jacksonville and the Jacksonville  
26 Transportation Authority, attached hereto as **Exhibit 1** and  
27 incorporated herein by this reference. The purpose of the Agreement  
28 is to extend the term of the Program and also to allow JTA to expand  
29 the "Door-To-Store" Program, as approved by Ordinance 2021-46-E and  
30 previously expanded by Ordinance 2021-140-E, to provide for an  
31 additional grocery store drop off site.

1           **Section 2.           Oversight Department.**   The Office of Economic  
2 Development shall oversee and administer the Program described  
3 herein.

4           **Section 3.           Effective Date.**   This ordinance shall become  
5 effective upon signature by the Mayor or upon becoming effective  
6 without the Mayor's signature.
