8 **ORDINANCE 2022-121**

9 AN ORDINANCE ADOPTING THE 2022 EDITION OF THE
10 JACKSONVILLE ORDINANCE CODE; ADOPTING BY
11 REFERENCE THE 46TH-56TH SUPPLEMENTS TO THE 1990
12 EDITION OF THE ORDINANCE CODE OF THE CITY OF
13 JACKSONVILLE AND THE CITY CHARTER, INCLUDING ALL
14 STATE LAWS, VOTED LAWS AND ORDINANCES OF GENERAL
15 AND PERMANENT NATURE ENACTED BY THE COUNCIL
16 THROUGH MARCH 22, 2022; RATIFYING GENERAL AND
17 PERMANENT ORDINANCES SO ADOPTED AND CONSIDERED
18 BY COUNCIL THROUGH MARCH 22, 2022; DIRECTIVE TO
19 CIVICPLUS CODIFIERS; PROVIDING AN EFFECTIVE
20 DATE.

22 **WHEREAS**, the legislative act of statutory adoption, or
23 codification, is a mechanism for establishing a single, unified
24 Ordinance Code, which summarizes and codifies all separate Ordinances
25 which have independently amended various portions of the Ordinance
26 code; and

27 **WHEREAS**, codification adopts the Ordinance Code of the City of
28 Jacksonville as the official statutory law of the Consolidated City;
29 and

30 **WHEREAS**, each such adoption includes within it the previously
31 adopted and codified Ordinances as well as all the City's Ordinances

1 amending the Ordinance Code adopted by the City Council in the
2 previous sessions from the previous year or years; and

3 **WHEREAS**, this codification provides to the people of
4 Jacksonville a definitive version of the Ordinance Code; and

5 **WHEREAS**, the Florida courts have regularly and consistently
6 approved this procedure, *see, e.g., State ex rel. Badgett v. Lee*, 22
7 So.2d 804 (Fla 1945); *Thompson v. Intercounty Tel. & Tel. Co.*, 62
8 So.2d 16 (Fla. 1952); *Rodriguez v. Jones*, 64 So.2d 27 (Fla 1953),
9 *Spangler v. Florida State Tpk. Auth.*, 106 So. 2d 421, 423 (Fla. 1958);
10 and

11 **WHEREAS**, in 1990 the City last adopted a complete revision of
12 the City's Official Ordinance Code; and

13 **WHEREAS**, for approximately ten years subsequent to the adoption
14 of that 1990 Ordinance Code, the City Council adopted, by Ordinance,
15 supplements to that 1990 Ordinance Code; and

16 **WHEREAS**, around the year 1999 or 2000 the City's Ordinance Code
17 has been published electronically; and

18 **WHEREAS**, due to the convenience of electronic publication, the
19 City Council has not adopted these supplements by Ordinance; and

20 **WHEREAS**, the City Council seeks to return to its process of
21 codification on a regular basis; and

22 **WHEREAS**, in 2017 the Council began the readoption process in
23 Ordinance 2017-236-E, the Council adopted supplements through March
24 16, 2017; and

25 **WHEREAS**, Ordinance 2017-236-E was the last adoption of the last
26 supplement to the 1990 Ordinance Code, approximately 10 supplements
27 have been published; and

28 **WHEREAS**, the City Council seeks to provide that same clarity to
29 the Ordinance Code of the City of Jacksonville as the Legislature
30 provides to Florida Statutes through Legislature's codification
31 process; now therefore

1 **BE IT ORDAINED** by the Council of the City of Jacksonville:

2 **Section 1.** The Ordinance Code of the City of Jacksonville,
3 1990 Edition, was adopted by Ordinance 91-305-142 and readopted with
4 Supplements 1, 2 and 3 incorporated therein by Ordinance 93-171-86,
5 Supplement 4 incorporated therein by Ordinance 93-548-327, Supplement
6 5 incorporated therein by Ordinance 93-929-396, Supplement 6
7 incorporated therein by Ordinance 94-1064-587, Supplement 7
8 incorporated therein by Ordinance 95-340-244, Supplement 8
9 incorporated therein by Ordinance 95-912-501, Supplement 9
10 incorporated therein by Ordinance 96-112-67, Supplement 10
11 incorporated therein by Ordinance 96-694-389, Supplement 11
12 incorporated therein by Ordinance 97-204-E, Supplement 12
13 incorporated therein by Ordinance 97-963-E, Supplement 13
14 incorporated therein by Ordinance 98-382-E, Supplement 14
15 incorporated therein by Ordinance 98-626-E, Supplement 15
16 incorporated therein by Ordinance 1999-42-E, and Supplements 16-45
17 incorporated therein by Ordinance 2017-236-E. The City Council hereby
18 amends by the adoption by reference herein the 1990 Edition of the
19 Ordinance Code of the City of Jacksonville, as modified above and by
20 Supplements 46th-56th hereby referenced herein. Copies of Supplements
21 46-56 are attached hereto as **Revised On File**, having been **Revised On**
22 **File** for at least ten days immediately preceding the passage of this
23 Ordinance and shall remain as a permanent record of the Council. The
24 1990 Edition of the Ordinance Code as amended and modified by
25 Supplements 1-56 is adopted and enacted as the official codification
26 of the general and permanent Ordinances of the City.

27 **Section 2.** All Ordinances and parts thereof of a general
28 and permanent nature incorporated within the supplements hereby
29 adopted, which were enacted by the Council through March 22, 2022,
30 are ratified by incorporation hereby. These Ordinances are listed in
31 **Revised On File** document and made a part hereof.
