4 **ORDINANCE 2022-32-W**

5 AN ORDINANCE AUTHORIZING THE MAYOR, OR HIS
6 DESIGNEE, AND THE CORPORATION SECRETARY TO
7 EXECUTE AND DELIVER A LOCALLY-FUNDED AGREEMENT
8 (LUMP-SUM) BETWEEN THE STATE OF FLORIDA
9 DEPARTMENT OF TRANSPORTATION ("FDOT") AND THE
10 CITY OF JACKSONVILLE PURSUANT TO WHICH THE CITY
11 AGREES TO PAY FDOT \$1,200,000 FOR CERTAIN
12 ROADWAY IMPROVEMENTS; PROVIDING FOR OVERSIGHT BY
13 THE ENGINEERING AND CONSTRUCTION MANAGEMENT
14 DIVISION OF THE DEPARTMENT OF PUBLIC WORKS;
15 PROVIDING AN EFFECTIVE DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Authorization to Execute.** The Mayor, or his
19 designee, and the Corporation Secretary are hereby authorized to
20 execute and deliver, for and on behalf of the City, that certain
21 Locally-Funded Agreement (Lump-Sum) between the State of Florida
22 Department of Transportation ("FDOT") and the City of Jacksonville,
23 in substantially the same form as is attached hereto as **Exhibit 1** and
24 incorporated herein by this reference (the "Agreement"). Pursuant
25 to the Agreement, the City of Jacksonville agrees to provide a
26 contribution of \$1,200,000 to help fund certain roadway improvements
27 on Main Street (SR 5/US 17). These improvements include milling and
28 resurfacing on Main Street from State Street to the Trout River and
29 installation of traffic calming improvements from 1st Street to 12th
30 Street. The City's contribution will be funded from a proposed
31 project in the fiscal year 2022-2023 Capital Improvement Plan and is

1 contingent upon City Council approval.

2 **Section 2. Oversight.** The Engineering and Construction
3 Management Division of the Department of Public Works shall oversee
4 the project described herein.

5 **Section 3. Effective Date.** This Ordinance shall become
6 effective upon signature by the Mayor or upon becoming effective
7 without the Mayor's signature.
