4 **ORDINANCE 2022-327**

5 AN ORDINANCE DECLARING THAT CERTAIN PARCEL OF  
6 REAL PROPERTY, A TAX REVERTED PARCEL, LOCATED AT  
7 3050 NOLAN STREET, R.E. NUMBER 057304-0000, IN  
8 COUNCIL DISTRICT 9 (THE "SUBJECT PARCEL"), TO BE  
9 SURPLUS TO THE NEEDS OF THE CITY; WAIVING  
10 SECTION 122.423 (DISPOSITION FOR AFFORDABLE  
11 HOUSING), PART 4 (REAL PROPERTY) OF CHAPTER 122  
12 (PUBLIC PROPERTY), *ORDINANCE CODE*, TO ALLOW FOR  
13 THE CONVEYANCE OF THE SUBJECT PARCEL TO CITY  
14 RESCUE MISSION, INC., THE NEIGHBORING PROPERTY  
15 OWNER ON ALL SIDES, AT NO COST; AUTHORIZING THE  
16 MAYOR AND THE CORPORATION SECRETARY TO EXECUTE  
17 ANY AND ALL DOCUMENTS NECESSARY FOR SUCH  
18 CONVEYANCE; PROVIDING A RIGHT OF REENTRY FOR  
19 FAILURE TO USE THE SUBJECT PARCEL FOR THE  
20 EXPANSION OF LOW-INCOME HOUSING; PROVIDING FOR  
21 CITY OVERSIGHT BY THE DEPARTMENT OF PUBLIC  
22 WORKS, REAL ESTATE DIVISION; PROVIDING AN  
23 EFFECTIVE DATE.

25 **WHEREAS**, the property owners failed to pay the ad valorem taxes  
26 due and owing on the property located at 3050 Nolan Street, R.E.  
27 Number 122274-0000, in Council District 9, Jacksonville, Florida (the  
28 "Subject Parcel"); and

29 **WHEREAS**, on September 21, 2020, the Subject Parcel reverted to  
30 the City of Jacksonville for unpaid taxes; and

31 **WHEREAS**, the City of Jacksonville has expended funds and

1 resources in maintaining the Subject Parcel; and

2 **WHEREAS**, the City of Jacksonville, Division of Landscape and  
3 Mowing is charged with mowing the property 8 times a year; and

4 **WHEREAS**, the neighboring property owner, City Rescue Mission,  
5 Inc., would like for the City to donate at no cost the Subject  
6 Property, a parcel on which the City continues to expend City  
7 resources without use for the parcel; and

8 **WHEREAS**, the City Rescue Mission, Inc. owns several adjacent  
9 properties on Nolan Street and intends to make the Subject Parcel  
10 useful to the neighborhood and the community for low-income housing  
11 expansion;

12 **WHEREAS**, the Subject Parcel is valued by the Property Appraiser  
13 at \$6,675.00; and

14 **WHEREAS**, the Council finds it to be in the best interest of the  
15 public to convey the Subject Parcel to City Rescue Mission, Inc.; now  
16 therefore

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Declaration of Surplus.** The City hereby  
19 declares that certain parcel of real property located at 3050 Nolan  
20 Street, R.E. Number 057304-0000, in Council District 9, and more  
21 particularly described in **Exhibit 1**, attached hereto and incorporated  
22 herein by this reference (the "Subject Parcel"), to be surplus to the  
23 needs of the City of Jacksonville. The Subject Parcel is a tax  
24 reverted vacant lot that reverted to the City on September 21, 2020.  
25 A copy of the certificate from the Chief of Real Estate for the  
26 surplus of real property, required by Rule 3.102 (Preparation of  
27 Bills), is attached hereto as **Exhibit 2**.

28 **Section 2. Waiving Section 122.423 (Disposition for**  
29 **Affordable Housing), Part 4 (Real Property) of Chapter 122 (Public**  
30 **Property), Ordinance Code.** The provisions of Section 122.423  
31 (Disposition for Affordable Housing), Part 4 (Real Property), of

1 Chapter 122 (Public property), *Ordinance Code*, are hereby waived in  
2 order to allow the conveyance of the Subject Parcel to the neighboring  
3 property owner on all sides, City Rescue Mission, Inc., at no cost  
4 for the expansion of low-income housing. Waiver of the Code is  
5 necessary in order to convey the Subject Parcel, rather than complying  
6 with the requirement of 122.423 that the parcel be disposed of through  
7 the affordable housing donation process.

8 **Section 3. Execution of conveyance documents authorized.**

9 The Mayor, or his designee, and the Corporation Secretary are  
10 authorized to execute all documents necessary to convey the Subject  
11 Parcel to City Rescue Mission, Inc.

12 **Section 4. Use and Right of Reentry.** The Subject Parcel

13 shall be used by City Rescue Mission, Inc. for low-income housing.  
14 If the Subject Property is used for anything other than the operation  
15 of such programs consistent with City Rescue Mission, Inc.'s core  
16 mission, the City shall have the right, but not the duty, to reenter  
17 the Subject Property and upon exercise of such reentry, all right,  
18 title, and interest of City Rescue Mission, Inc. shall revert to the  
19 City; and City Rescue Mission, Inc. shall execute and deliver its  
20 Special Warranty Deed to the City free of all liens and encumbrances.

21 **Section 5. Oversight Department.** The Department of Public

22 Works, Real Estate Division shall oversee the operations described  
23 in this ordinance; if the use provisions in Section 4 are not  
24 maintained, the Real Estate Division, through the Office of General  
25 Counsel, may initiate action for reverter.

26 **Section 6. Effective Date.** This ordinance shall become

27 effective upon signature by the Mayor or upon becoming effective  
28 without the Mayor's signature.
