ORDINANCE 2022-330

AN ORDINANCE REGARDING CHAPTER 745 (ADDRESSING AND STREET NAMING REGULATIONS), ORDINANCE CODE; ESTABLISHING AN HONORARY STREET DESIGNATION AND ASSOCIATED ROADWAY MARKERS FOR ENGINEER MICHAEL L. FREELAND, A FALLEN FIRE AND RESCUE OFFICER WHO DIED WHILE IN THE LINE OF DUTY; ESTABLISHING AN HONORARY STREET DESIGNATION ON AVIATION AVENUE IN COUNCIL DISTRICT 12 FOR ENGINEER MICHAEL L. FREELAND; PROVIDING FOR THE ROADSIDE MARKERS FOR ENGINEER MICHAEL L. FREELAND BE DEPICTED AS CONTEMPLATED IN SECTION 745.105 (J) (9) (B), ORDINANCE CODE; PROVIDING FOR THE INSTALLATION OF TWO HONORARY ROADWAY MARKERS TO BE LOCATED IN APPROPRIATE LOCATIONS ON THE DESIGNATED ROADWAY IN COUNCIL DISTRICT 12; WAIVER OF SECTION 745.105 (I)(2), ORDINANCE CODE, WHICH REQUIRES THAT THE HONOREE BE DECEASED FOR AT LEAST 5 YEARS; WAIVER OF SECTION 745.102(I)(3), ORDINANCE CODE, WHICH REQUIRES THE HONOREE TO LIVE WITHIN 5 MILES OF THE DESIGNATED ROADWAY FOR 10 YEARS; DIRECTING THE LEGISLATIVE SERVICES DIVISION TO FORWARD THIS ORDINANCE TO THE PLANNING AND DEVELOPMENT DEPARTMENT FOR PROCESSING, IMPLEMENTATION, AND COORDINATION WITH THE PUBLIC WORKS DEPARTMENT, TRAFFIC ENGINEERING AND OTHER AFFECTED AGENCIES AND ORGANIZATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Jacksonville Fire and Rescue Department (JFRD) submitted a request for an Honorary Street Name Designation to honor Fire and Rescue Engineer Michael L. Freeland; (Correspondence from the Office of the Director/Fire Chief, City of Jacksonville Fire and Rescue Department is attached hereto as Exhibit 1); and

WHEREAS, Section 745.105 (j) (9) (b), Ordinance Code, provides for honorary designations for fallen fire and rescue officers who die while in the Line of Duty; and

WHEREAS, Engineer Freeland died while in the Line of Duty while attempting to disentangle a patient from a heavily damaged truck impaled by a power pole. Freeland collapsed at the scene of the incident, and ultimately, was declared deceased; and

WHEREAS, for 6 years, Engineer Freeland worked as a part of the Aircraft Rescue Firefighting Unit (ARFF,) and was assigned to Fire Station 73; and

WHEREAS, Engineer Freeland participated, with fierce dedication,
in the COVID testing and vaccination effort during the Pandemic; and
 WHEREAS, the Florida Joint Council of Fire and Emergency
Services will honor Engineer Freeland's name on the Memorial Wall at
the Florida Fallen Firefighter Memorial in Ocala, Florida, and at the
State Capitol; (See attached Exhibit 1); and

WHEREAS, the City of Jacksonville Fire and Rescue Department recognized the memory of Engineer Freeland which included a "Ringing of the Bell" ceremony, a "Last Guard" ritual, presentation of a Fallen Firefighter Memorial Flag and a medallion; and

WHEREAS, pursuant to Section 745.105 (j)(10), Ordinance Code, the Planning and Development Department mailed written notifications on January 12, 2022, and on March 8, 2022, to affected property owners requesting that the affected property owners to indicate their written consent or objection to the proposed honorary street designation.

Copies of the January 12, 2022, and March 8, 2022, letters are attached as **Exhibit 2** and **Exhibit 3**; and

WHEREAS, because no property owners responded to the notifications from the Planning and Development Department, the property owners are deemed to have consented to the proposed honorary street designation; and

WHEREAS, the Council finds that the accomplishments of Engineer Michael L. Freeland are worthy and deserving of a form of recognition that the City of Jacksonville and Engineer Michael L. Freeland's family, friends and colleagues can share and celebrate in, to wit: the creation of an honorary street designation and the installation of two appropriate honorary roadway markers on Aviation Avenue in Council District 12; now therefore,

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Aviation Avenue to receive an honorary street designation for Engineer Michael L. Freeland. Aviation Avenue in Council District 12 shall hereby be designated as contemplated by Section 745.105, Ordinance Code, for Engineer Michael L. Freeland. A map of the road designation is attached hereto as Exhibit 4.

Section 2. Honorary Roadside Markers for Engineer Michael L. Freeland to be depicted as authorized in Section 745.105 (j) (9) (a)-(b), Ordinance Code. Two honorary roadside markers shall depict the appropriate badge and/or emblem color for Engineer Michael L. Freeland as contemplated in Section 745.105 (j) (9) (a)-(b), Ordinance Code, to read as follows:

Fire and Rescue Officer

Engineer Michael L. Freeland

End of Watch

November 11, 2021

Section 3. Honorary Roadside Markers for Engineer Michael

L. Freeland to be installed. Two honorary roadside markers, as

contemplated by Section 745.105, Ordinance Code, recognizing and honoring Engineer Michael L. Freeland shall be placed in appropriate locations at the intersection of Aviation Avenue and Lake Fretwell Street extending to Crossover Street in front of Fire Station 73 in Jacksonville.

Section 4. Waiver of Section 745.105(i)(2), Ordinance Code.

Section 745.105(i)(2), Ordinance Code, which requires that the honoree be deceased for a least five years is hereby waived due to the fact that the honoree died while in the Line of Duty.

Section 5. Waiver of Section 745.105(i) (3), Ordinance Code. Section 745.105(i) (3), Ordinance Code, which requires that the honoree live within 5 miles of the designated road for 10 years is hereby waived because the honoree was assigned to work at Station 73 which is located on the designated roadway.

Section 6. Directing Legislative Services to forward a copy to the Planning and Development Department. The Chief of Legislative Services is requested to send a copy of this legislation, once enacted, to the Planning and Development Department, Addressing Unit, for processing, implementation, and coordination with the Public Works Department, Traffic Engineering Division and other affected agencies and organizations.

Section 7. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
