RE: Honorary Street Designation for Officer Michael L Freeland on Aviation Avenue extending from 103rd Street to Airman Drive

Dear Property Owner,

In accordance with Section 745.105, Jacksonville Ordinance Code, the City of Jacksonville ("City") received a request for an honorary street designation along Aviation Avenue in the location of property that you own, identified as Real Estate Number (RE#) 002249 0005.

Specifically, the Jacksonville Fire and Rescue Department (JFRD) submitted a request for an honorary street designation on Aviation Avenue, extending from 103rd Street to Airman Drive, to honor "Officer Michael L Freeland", a fallen fire and rescue officer who died while in the line of duty.

An honorary street designation allows the City to recognize the achievements of prominent individuals in Jacksonville without changing the official street name of a roadway. The honorary street designation simply allows a second honorary name to exist on a road or road segment, and also allows for the placement of two honorary street markers at each end of the designated roadway.

The establishment of an honorary designation on this roadway requires the approval of 75% of the owners whose properties are addressed from the roadway. Since you own property that is addressed from Aviation Avenue in the location of the proposed honorary designation, please indicate your approval or objection to the proposed establishment of an Honorary Designation for "Officer Michael Freeland".

If 75% of the property owners agree to the proposed honorary street designation, legislation will be presented to the Jacksonville City Council for a final decision concerning the designation. In addition, you will be notified of the date, time and location of any public hearings pertaining to this designation.
