6 **ORDINANCE 2022-211-E**

7 AN ORDINANCE APPROPRIATING \$36,000.00 IN FUND
8 BALANCE FROM THE ENVIRONMENTAL PROTECTION FUND
9 (THE "FUND") TO PROVIDE FUNDING FOR NATURAL
10 RESOURCE EDUCATION OUTREACH ACTIVITIES HOSTED BY
11 THE DUVAL SOIL AND WATER CONSERVATION DISTRICT
12 (THE "DISTRICT"), AS INITIATED BY REVISED B.T.
13 22-055; PURPOSE OF APPROPRIATION; PROVIDING FOR
14 CARRYOVER OF FUNDS THROUGH SEPTEMBER 30, 2024;
15 APPROVING, AND AUTHORIZING THE MAYOR, OR HIS
16 DESIGNEE, AND THE CORPORATION SECRETARY TO
17 EXECUTE AND DELIVER A MEMORANDUM OF
18 UNDERSTANDING BETWEEN THE CITY OF JACKSONVILLE
19 ENVIRONMENTAL PROTECTION BOARD AND THE DUVAL
20 SOIL AND WATER CONSERVATION DISTRICT; WAIVING
21 SECTION 110.112 (ADVANCE OF CITY FUNDS;
22 PROHIBITION AGAINST), PART 1 (THE CITY
23 TREASURY), CHAPTER 110 (CITY TREASURY),
24 *ORDINANCE CODE*, TO ALLOW FOR A PARTIAL ADVANCE
25 PAYMENT BY THE CITY; PROVIDING FOR OVERSIGHT BY
26 THE NEIGHBORHOODS DEPARTMENT; REQUIRING ANNUAL
27 REPORTING TO THE JACKSONVILLE ENVIRONMENTAL
28 PROTECTION BOARD; PROVIDING AN EFFECTIVE DATE.

30 **BE IT ORDAINED** by the Council of the City of Jacksonville:

31 **Section 1. Appropriation.** For the 2021-2022 fiscal year,

1 within the City's budget, there are hereby appropriated the indicated
2 sum(s) from the account(s) listed in subsection (a) to the account(s)
3 listed in subsection (b):

4 (Revised B.T. 22-055 attached hereto as **Revised Exhibit 1**, labeled
5 as "Revised Exhibit 1, Revised B.T. 22-055, April 18, 2022 - NCSPHS"
6 and incorporated herein by this reference)

11 (c) Explanation of Appropriation:

12 The funding above represents an appropriation of \$36,000.00
13 from the Environmental Protection Trust Fund (the "Fund")
14 fund balance to support the expansion of natural resources
15 education programming to students ranging from
16 kindergarten through 12th grade.

17 **Section 2. Purpose.** The purpose of the appropriation in
18 Section 1 is to support expansion of natural resources education
19 activities and events hosted by the Duval Soil and Water Conservation
20 District (the "District"). These activities are designed to enhance
21 awareness and promote the conservation of natural resources and will
22 specifically target students, beginning farmers, and underserved
23 populations residing in the urban core through activities such as the
24 Envirothon, Start Farming Workshops, Regeneration Park Workshops, and
25 various contests. The Jacksonville Environmental Protection Board
26 approved this expenditure during its meeting on January 18, 2022, as
27 reflected in the Monthly Meeting Summary attached hereto as **Exhibit**
28 **2.**

29 **Section 3. Carryover.** The funds appropriated in this
30 Ordinance shall not lapse but shall carryover through September 30,
31 2024.

1 **Section 4. Agreement Approved and Execution Authorized.**

2 There is hereby approved, and the Mayor, or his designee, and the
3 Corporation Secretary are hereby authorized to execute and deliver,
4 the Memorandum of Understanding between the City of Jacksonville
5 Environmental Protection Board and the District, in substantially the
6 same form as attached hereto as **Revised Exhibit 3**, labeled as "Revised
7 Exhibit 3, Revised Agmt, April 18, 2022 - NCSPHS" and incorporated
8 herein by this reference (the "Agreement"). The Agreement may include
9 any respective extension or amendments thereto as necessary and
10 appropriate to effectuate the intent of this ordinance; provided,
11 however, no modifications to the Agreement may increase the financial
12 obligations or the liability of the City to an amount in excess of
13 the amount stated in the Agreement or decrease the duties and
14 obligations of the District as stated in the Agreement.

15 **Section 5. Waiving Section 110.112, Ordinance Code.**

16 Section 110.112 (Advance of City funds; prohibition against), Part 1
17 (The City Treasury), Chapter 110 (City Treasury), *Ordinance Code*, is
18 hereby waived to allow for a partial advance payment to the Duval
19 Soils and Water Conservation District as provided in the Agreement.

20 **Section 6. Oversight.** The Environmental Quality
21 Division of the Neighborhoods Department shall provide oversight of
22 the project described herein.

23 **Section 7. Annual Reports.** The District is required to
24 provide an annual report to the Jacksonville Environmental Protection
25 Board by September 15th of each year for the duration of the Agreement.

26 **Section 8. Effective Date.** This Ordinance shall become
27 effective upon signature by the Mayor or upon becoming effective
28 without the Mayor's signature.
