BE IT ORDAINED by the Council of the City of Jacksonville:

21 Section 1. Closure and Abandonment. An opened and improved 22 portion of the Pearce Street right-of-way established in the Grand 23 Boulevard Plat, as recorded in Plat Book 3, Page 89 of the current 24 public records of Duval County, Florida, located in Council District 8, a description and depiction of which is attached hereto as Exhibit 25 26 1 and incorporated herein by this reference, is hereby closed and abandoned and/or disclaimed as a right-of-way at the request of 27 Greater Friendly Missionary Baptist Church Inc. (the "Applicant"); 28 29 provided however, there is reserved unto JEA an all utilities, 30 facilities and access easement on, over, under, through and across the closed right-of-way area for ingress and egress and for all 31

1 utilities and facilities, including but not limited to, water, sewer 2 and electric, so as to provide JEA continued access to repair and 3 maintain these utilities and facilities. In addition, a utility 4 easement shall be reserved in favor of AT&T over the northerly 25 5 feet of the closure area.

6 The Applicant paid the right-of-way closure application fee of 7 \$2,091.00 and this amount has been deposited into the General Fund. 8 This closure request was reviewed and approved by the various city, 9 state, and utility agencies that might have an interest in the right-10 of-way and there were no objections to the Applicant's request.

11 Section 2. Purpose. The Applicant owns property adjacent 12 to the closure area at 1664 W. 19th Street (R.E. No. 046071-0000) and 13 is requesting the closure in order to construct a paved parking lot 14 and running track for the neighborhood's use, subject to the 15 conditions set forth herein.

Section 3. Hold Harmless Covenant. The 16 closure and 17 abandonment by the City of its interests in the right-of-way is subject to Applicant's execution and delivery to the City of a Hold 18 19 Harmless Covenant, in substantially the same form attached hereto as Exhibit 2 and incorporated herein by this reference. Accordingly, 20 21 the closure and abandonment of the right-of-way shall not be recorded 22 in the public records until execution and delivery to the City by the 23 Applicant of the required Hold Harmless Covenant.

Section 4. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
