The Consolidated Appropriation Act, 2021 requires the U.S Department of the Treasury to begin reallocating "excess" ERA1 funds for use to certain eligible grantees to be used to provide Emergency Rental Assistance (ERAP) to eligible households not to exceed 18 months for payments of rent, rental arrears, utilities and home energy costs; utilities and home energy costs arrears and other expenses related to housing.


