WHEREAS, Clark Vargas graduated from Jacksonville's Englewood High School, served several years in the U.S. Army Corps of Engineer, and earned his bachelor's degree in Civil Engineering and his master's degree in Hydraulics and Environmental Engineering from the University of Florida; and

WHEREAS, Mr. Vargas held positions with two local engineering firms before founding C. Vargas & Associates, Ltd. Engineers in 1977. One of Jacksonville's leading civil engineering firms, C. Vargas & Associates has performed a wide variety of engineering work for clients in Jacksonville and Northeast Florida, as well as nationally; and

WHEREAS, Clark Vargas is an expert marksman and long-time competitive shooter at the national and international level. He competed in the trials for a spot on the U.S. Olympic pistol team in 1990 and is Past President and a life member of the Florida Sport Shooting Association, an Endowment Member of the National Rifle Association of America, a Life Member of the United States Practical Shooting Association, a Life Member and past Territorial Governor of the Single Action Shooting Society, and a Past Vice President of the First Coast Sports Shooting Association; and
