7 A RESOLUTION CONFIRMING THE REAPPOINTMENT OF  
8 KAREN ESTELLA SMITH AS A MEMBER OF THE CULTURAL  
9 SERVICE GRANT PROGRAM COMMITTEE, AS ONE OF THE  
10 SEVEN COMMUNITY REPRESENTATIVES, PURSUANT TO  
11 SECTION 118.605, *ORDINANCE CODE*, FOR A FIRST  
12 FULL TERM EXPIRING DECEMBER 31, 2024; PROVIDING  
13 AN EFFECTIVE DATE.

15 **WHEREAS**, pursuant to §118.605(a), *Ordinance Code*, the membership  
16 of the Cultural Service Grant Program Committee shall be comprised  
17 of 10 voting members (3 Cultural Council Board Members and 7  
18 individuals from the community appointed by the Cultural Council  
19 Board President, Cultural Service Grant Program Committee Chair, and  
20 the 3 Cultural Council Board Members); and

21 **WHEREAS**, Resolution 2020-457-A appointed Karen Estella Smith to  
22 the Cultural Service Grant Program Committee with a partial term  
23 ending December 31, 2021; and

24 **WHEREAS**, the Cultural Council Board would like to reappoint Ms.  
25 Smith to the Cultural Service Grant Program Committee, as one of the  
26 seven community representatives, for a first full term; and

27 **WHEREAS**, pursuant to §118.605(d), *Ordinance Code*, all members  
28 of the Cultural Service Grant Program Committee shall be confirmed  
29 by the City Council; now therefore

30 **BE IT RESOLVED** by the Council of the City of Jacksonville:

31 **Section 1. Reappointment.** The Council hereby confirms the

1 reappointment of Karen Estella Smith, a Duval County resident, to the  
2 Cultural Service Grant Program Committee, as one of the seven  
3 community representatives, pursuant to §118.605, *Ordinance Code*, for  
4 a first full term ending December 31, 2024.

5       **Section 2.       Effective Date.** This resolution shall become  
6 effective upon signature by the Mayor or upon becoming effective  
7 without the Mayor's signature.
