ORDINANCE 2022-327-E

AN ORDINANCE DECLARING THAT CERTAIN PARCEL OF REAL PROPERTY, A TAX REVERTED PARCEL, LOCATED AT 3050 NOLAN STREET, R.E. NUMBER 057304-0000, IN COUNCIL DISTRICT 9 (THE "SUBJECT PARCEL"), TO BE SURPLUS TO THE NEEDS OF THE CITY; WAIVING SECTION 122.423 (DISPOSITION FOR AFFORDABLE HOUSING), PART 4 (REAL PROPERTY) OF CHAPTER 122 (PUBLIC PROPERTY), ORDINANCE CODE, TO ALLOW FOR THE CONVEYANCE OF THE SUBJECT PARCEL TO CITY RESCUE MISSION, INC., THE NEIGHBORING PROPERTY OWNER ON ALL SIDES, AT NO COST; AUTHORIZING THE MAYOR AND THE CORPORATION SECRETARY TO EXECUTE ANY AND ALL DOCUMENTS NECESSARY FOR SUCH CONVEYANCE; PROVIDING A RIGHT OF REENTRY FOR FAILURE TO USE THE SUBJECT PARCEL FOR THE EXPANSION OF LOW-INCOME HOUSING; AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER, FOR AND ON BEHALF OF THE CITY, A DONATION AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND CITY RESCUE MISSION, INC.; PROVIDING FOR CITY OVERSIGHT BY THE DEPARTMENT OF PUBLIC WORKS, REAL ESTATE DIVISION AND THE DEPARTMENT OF NEIGHBORHOODS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the property owners failed to pay the ad valorem taxes due and owing on the property located at 3050 Nolan Street, R.E. Number 057304-0000, in Council District 9, Jacksonville, Florida (the "Subject Parcel"); and

WHEREAS, on September 21, 2020, the Subject Parcel reverted to the City of Jacksonville for unpaid taxes; and

WHEREAS, the City of Jacksonville has expended funds and resources in maintaining the Subject Parcel; and

WHEREAS, the City of Jacksonville, Division of Landscape and Mowing is charged with mowing the property 8 times a year; and

WHEREAS, the neighboring property owner, City Rescue Mission, Inc., would like for the City to donate at no cost the Subject Property, a parcel on which the City continues to expend City resources without use for the parcel; and

WHEREAS, the City Rescue Mission, Inc. owns several adjacent properties on Nolan Street and intends to make the Subject Parcel useful to the neighborhood and the community for low-income housing expansion;

WHEREAS, the Subject Parcel is valued by the Property Appraiser at \$6,675.00; and

WHEREAS, the Council finds it to be in the best interest of the public to convey the Subject Parcel to City Rescue Mission, Inc.; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Declaration of Surplus. The City hereby declares that certain parcel of real property located at 3050 Nolan Street, R.E. Number 057304-0000, in Council District 9, and more particularly described in Exhibit 1, attached hereto and incorporated herein by this reference (the "Subject Parcel"), to be surplus to the needs of the City of Jacksonville. The Subject Parcel is a tax reverted vacant lot that reverted to the City on September 21, 2020.

A copy of the certificate from the Chief of Real Estate for the surplus of real property, required by Rule 3.102 (Preparation of Bills), is attached hereto as **Exhibit 2**.

122.423 (Disposition Section 2. Waiving Section for Affordable Housing), Part 4 (Real Property) of Chapter 122 (Public Property), Ordinance Code. The provisions of Section 122.423 (Disposition for Affordable Housing), Part 4 (Real Property), of Chapter 122 (Public property), Ordinance Code, are hereby waived in order to allow the conveyance of the Subject Parcel to the neighboring property owner on all sides, City Rescue Mission, Inc., at no cost for the expansion of low-income housing. Waiver of the Code is necessary in order to convey the Subject Parcel, rather than complying with the requirement of 122.423 that the parcel be disposed of through the affordable housing donation process.

Section 3. Execution of conveyance documents authorized. The Mayor, or his designee, and the Corporation Secretary are authorized to execute all documents necessary to convey the Subject Parcel to City Rescue Mission, Inc.

Section 4. Use and Right of Reentry. The Subject Parcel shall be used by City Rescue Mission, Inc. for low-income housing. If the Subject Property is used for anything other than the operation of such programs consistent with City Rescue Mission, Inc.'s core mission, the City shall have the right, but not the duty, to reenter the Subject Property and upon exercise of such reentry, all right, title, and interest of City Rescue Mission, Inc. shall revert to the City; and City Rescue Mission, Inc. shall execute and deliver its Special Warranty Deed to the City free of all liens and encumbrances.

Section 5. Approval and authorization of Donation Agreement. There is hereby approved, and the Mayor, or his designee, and the Corporation Secretary are hereby authorized to execute and deliver, for and on behalf of the City, a Property Donation Agreement

between the City of Jacksonville and City Rescue Mission, Inc., attached hereto as **Revised Exhibit 3**, labeled as "Revised Exhibit 3, Rev Agmt, May 24, 2022 - Floor" and incorporated herein by this reference.

Section 6. Oversight Department. The Department of Public Works, Real Estate Division and the Department of Neighborhoods shall oversee the operations described in this ordinance; if the use provisions in Section 4 are not maintained, the Real Estate Division and the Department of Neighborhoods, through the Office of General Counsel, may initiate action for reverter.

Section 7. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
