3 **ORDINANCE 2022-459**

4 AN ORDINANCE REGARDING CHAPTER 745 (ADDRESSING  
5 AND STREET NAMING REGULATIONS) ORDINANCE CODE;  
6 ESTABLISHING AN HONORARY STREET DESIGNATION AND  
7 ASSOCIATED ROADWAY MARKERS FOR ERNEST GIBSON;  
8 ESTABLISHING AN HONORARY STREET DESIGNATION ON  
9 MINOSA COURT EXTENDNG FROM 45<sup>TH</sup> STREET WEST TO A  
10 DEAD END IN COUNCIL DISTRICT 10 FOR ERNEST  
11 GIBSON; PROVIDING FOR THE INSTALLATION OF TWO  
12 HONORARY ROADWAY MARKERS TO BE LOCATED IN  
13 APPROPRIATE LOCATIONS ON THE DESIGNATED ROAD IN  
14 COUNCIL DISTRICT 10; WAIVER OF SECTION 745.105  
15 (I) (2) WHICH REQUIRES THAT THE HONOREE BE  
16 DECEASED FOR AT LEAST 5 YEARS; DIRECTING THE  
17 LEGISLATIVE SERVICES DIVISION TO FORWARD THIS  
18 ORDINANCE TO THE PLANNING AND DEVELOPMENT  
19 DEPARTMENT FOR PROCESSING, IMPLEMATION AND  
20 COORDINATION WITH THE PUBLIC WORKS DEPARTMENT,  
21 TRAFFIC ENGINEERING AND OTHER AFFECTED AGENCIES  
22 AND ORGANIZATIONS; PROVIDING AN EFFECTIVE DATE.  
23

24 **WHEREAS**, Ernest Gibson's legacy began in 1929 the year of his  
25 birth, and that legacy continues to impact Jacksonville and beyond;  
26 and

27 **WHEREAS**, while attending Stanton High School in 1946, Mr. Gibson  
28 joined the United States Army, and was assigned to serve in another  
29 country, Japan; and

30 **WHEREAS**, Mr. Gibson eventually returned home to complete his  
31 high school education in the affectionate care of his aunt and uncle;

2       **WHEREAS**, in 1954, Ernest Gibson earned a Bachelor's degree in  
3 Industrial Education at Tuskegee Institute, now known as Tuskegee  
4 University; and

5       **WHEREAS**, Tuskegee University, in 2007, inducted Mr. Gibson into  
6 the Tuskegee University Athletic Hall of Fame for competing in Track  
7 and Field while attending college in the 1950's; and

8       **WHEREAS**, Mr. Gibson was an active Tuskegee alumnus and  
9 consistently dedicated his time and effort participating in the  
10 "adopt-a-dorm" summer program literally using his own personal tools  
11 for making repairs to on-campus housing; and

12       **WHEREAS**, in June 1955, Ernest Gibson married Lois Glenda Davis  
13 who also attended Tuskegee. Their wedding was the first to be held  
14 at the new St. Paul AME Church on Myrtle Avenue, and their beautiful  
15 marriage lasted for 60 years until Mrs. Gibson passed in 2015; and

16       **WHEREAS**, Mr. Gibson's strong desire for education led him to  
17 enroll at Florida A & M University where he earned several teaching  
18 certificates in multiple subject areas, and later earned a Master's  
19 Degree in Education at the Florida State University; and

20       **WHEREAS**, Ernest Gibson worked in several administrative roles  
21 in various Jacksonville Schools, namely: Robert E. Lee Senior High,  
22 Southside Junior High School, Arlington Junior High School and  
23 Highlands Junior High School. He proudly served as the Wood Shop  
24 teacher, and a football coach at Douglas Anderson School; and

25       **WHEREAS**, in 2019, to honor his impactful legacy, Douglas  
26 Anderson School created the "Ernest Gibson Scholarship for Education"  
27 Fund. He was also recognized for his solid coaching and dedication  
28 by the African American Coaches, Game Officials and the Athletic  
29 Association; and

30       **WHEREAS**, after retirement from a fulfilling career, Ernest  
31 Gibson worked as a Truancy Officer for the Duval County Public School

1 District and part-time for GE Capital; and

2 **WHEREAS**, Mr. Gibson participated in several civic organizations,  
3 including but not limited to his beloved Kappa Alpha Psi Fraternity,  
4 Inc., the Tuskegee Alumni Association, the Johnson Branch YMCA Board  
5 of Directors, a Connecting Link, Jacksonville Chapter of the Links,  
6 Inc., a Mule, Jacksonville Chapter of the Moles, Inc., and a counselor  
7 to many; and

8 **WHEREAS**, pursuant to Section 745.105 (j)(10), Ordinance Code,  
9 the Planning and Development Department mailed written notifications  
10 on March 9, 2022, and on April 21, 2022, to affected property owners  
11 requesting the owners to indicate their written consent or objection  
12 to the proposed honorary street designation. A copy of the letters  
13 are attached as **Exhibits 1 and 2**; and

14 **WHEREAS**, on March 22, 2022, an affected property owner indicated  
15 their objection of the proposed honorary designation. A copy of the  
16 written objection is attached as **Exhibit 3**; and

17 **WHEREAS**, on April 27, 2022, an affected property owner indicated  
18 their consent of the proposed honorary designation. A copy of the  
19 written consent is attached as **Exhibit 4**; and

20 **WHEREAS**, the remaining affected property owners failed to  
21 respond to the written notifications. Pursuant to Section 745.105 (j  
22 (10), Ordinance Code, such non-response shall be deemed as an  
23 acceptance of the proposed honorary street designation; designation;  
24 and

25 **WHEREAS**, a private donor has remitted funds to satisfy the cost  
26 for the honorary markers (See attached **Exhibit 5**); and

27 **BE IT ORDAINED** by the Council of the City of Jacksonville:

28 **Section 1. Minosa Court to receive an honorary street**  
29 **designation for Ernest Gibson.** "Minosa Court" extending from West  
30 45th Street to a dead end in Council District 10, is hereby designated  
31 as contemplated by Section 745.105, Ordinance Code, for Ernest Gibson.

1 A map of the road designation is attached hereto as **Exhibit 6**.

2 **Section 2. Honorary Roadside Markers for Ernest Gibson to**  
3 **be installed.** Two honorary roadside markers, as contemplated by  
4 Section 745.105, Ordinance Code, recognizing and honoring Ernest  
5 Gibson shall be placed in appropriate locations on Minosa Court.

6 **Section 3. Waiver of Section 745.105 (i)(2), Ordinance**  
7 **Code.** Section 745.105(i)(2) which requires that the honoree be  
8 deceased for at least five years is hereby waived to honor Mr. Gibson  
9 now for his contributions to the community as he was a prominent  
10 figure who dedicated his life serving others until his death in 2021.

11 **Section 4. Directing Legislative Services Division to**  
12 **forward a copy to the Planning and Development Department.** The Chief  
13 of Legislative Services is requested to send a copy of this  
14 legislation, once enacted, to the Planning and Development  
15 Department, Addressing Unit, for processing, implementation, and  
16 coordination with the Public Works Department, Traffic Engineering  
17 Division and other affected agencies and organizations.

18 **Section 5. Effective Date.** This ordinance shall  
19 become effective upon signature by the Mayor or upon becoming  
20 effective without the Mayor's signature.
