

NCSPHS AMENDMENT

The Neighborhoods, Community Services, Public Health and Safety Committee offers the following amendment to File 2022-365:

- (1) On **page 1, line 6, and page 2, line 2, strike** "ANNUAL";

- (9) On **page 2, line 26, strike** "Exhibit 2" and **insert** "Revised Exhibit 2, labeled as "Revised Exhibit 2, Rev Schedule, June 6, 2022 - NCSPHS"";
- (10) On **page 2, line 27, after "reference." insert** "A copy of the award letters are attached hereto as **Exhibit 4.**";

- (11) Remove **Exhibit 1** and replace with **Revised Exhibit 1** attached hereto, which attaches Revised B.T. 23-002 to reflect corrected appropriation amount;
- (12) Remove **Exhibit 2** and replace with **Revised Exhibit 2** attached hereto, which attaches Revised Schedule of Proposed Funding to corrected appropriation amount;
- (13) Attach **Exhibit 4** attached hereto, which attaches the HUD grant award letters to identify award amounts;
- (14) On **page 1, line 1**, amend the introductory sentence to add that the bill was amended as reflected herein.
