

GLOBAL AMENDMENT TWO TO ECONOMIC DEVELOPMENT AGREEMENTS

This **GLOBAL AMENDMENT TWO TO ECONOMIC DEVELOPMENT AGREEMENTS** (this “Amendment”), dated as of _____, 2022 (the “Effective Date”) between the party of the first part the **CITY OF JACKSONVILLE**, a municipal corporation and a political subdivision of the State of Florida (the “City”) and each party of the second part listed on Exhibit A, and each hereinafter referred to as the “Company”.

RECITALS:

WHEREAS, the City and the Company previously entered into that certain Economic Development Agreement as further identified and set forth on Exhibit A attached hereto (the “Agreement”);

WHEREAS, the Agreement provides for certain incentives to the Company in connection with the Project, all as more particularly set forth in the Agreement (the “Incentives”);

WHEREAS, the Agreement requires, as a condition precedent to the Incentives, that the Company create certain New Jobs and that such New Jobs and the employees filling the New Jobs be located at certain and particular locations;

WHEREAS, due to the impacts resulting from the COVID-19 pandemic, including limitations with regard to workforce density and implementation of other protective measures, the City Council approved Global Amendment One to Economic Development Agreements via Ordinance 2021-449-E, which authorized certain employees working remotely to count with respect to New Jobs for calendar years 2020 and 2021, provided certain conditions were met; and

WHEREAS, the Company has requested that the City continue to allow such employees working remotely to count with respect to New Jobs after 2021 and through the end of the term of the Agreement; and

WHEREAS, the City recognizes and understands that the COVID-19 pandemic continues to impact the local workforce and has changed the workforce landscape for businesses in Jacksonville for the foreseeable future;

NOW, THEREFORE, in consideration of the mutual promises herein, and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged by each party, the City and the Company hereby agree as follows:

1. Recitals and Definitions. The above recitals are true and correct and are incorporated herein by this reference. All capitalized terms not otherwise defined herein shall have the meanings set forth in the Agreement.

2. Remote Employees. To the extent that the Incentives are conditioned upon a job and/or an employee being located at a certain and particular geographic location (the “Geographical Condition”), the Agreement is hereby amended to provide that, through the end of

the term of the Agreement, the Geographical Condition may, in addition to the manner set forth in the Agreement, be fulfilled with respect to such job and employee if the Company is able to demonstrate to the City that both of the following conditions were met during the applicable calendar year: (i) the employee filling the New Job resided within the geographical borders of the Metropolitan Statistical Area (comprised of Duval County, Clay County, St. Johns County, Nassau County and Baker County), and (ii) such New Job was based, but not necessarily located, at the Project Parcel. The foregoing shall not be construed as a waiver or modification of any other conditions or requirements under the Agreement with respect to the Incentives or otherwise.

3. Records. In addition to all other requirements in the Agreement, the Company shall provide any and all records and back-up documentation reasonably requested by the City in order to verify the residency of the Company's employees and the location of the New Jobs.

4. Counterparts. This Amendment is contingent, with respect to each Company, upon receipt by the City of a duly executed counterpart of this Amendment by such Company in form and substance acceptable to the City. This Amendment may be executed in more than one counterpart and all such counterparts taken together shall be deemed to constitute but one original document. A digital copy of this Amendment and any signatures to this Amendment may be delivered electronically via portable document format ("PDF"), "DocuSign" or other standard electronic transmission, and digital signatures so delivered shall constitute effective execution and delivery of such signature pages and shall be deemed to be the original signatures, and fully effective, for all purposes.

SAVE AND EXCEPT as expressly amended by this instrument, the provisions, terms and conditions in the Agreement shall remain unchanged and shall continue in full force and effect and are hereby ratified and confirmed.
