ORDINANCE 2022-495-E

AN ORDINANCE AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND CORPORATION SECRETARY TO EXECUTE AND DELIVER, FOR AND ON BEHALF OF THE CITY, (A) AN AMENDED AND RESTATED INDIGENT CARE AGREEMENT WITH SHANDS JACKSONVILLE MEDICAL CENTER, INC., AND (B) AN AMENDMENT TO THE DISPROPORTIONATE SHARE HOSPITAL LETTER OF AGREEMENT WITH THE STATE OF FLORIDA THROUGH ITS AGENCY FOR HEALTH CARE ADMINISTRATION, BOTH CONCERNING PAYMENT AND DISTRIBUTION OF THE CITY'S INDIGENT HEALTH CARE FUNDS IN THE AMOUNT OF \$35,000,000 FOR FISCAL YEAR 2021-2022, PREVIOUSLY AUTHORIZED PURSUANT TO THE BUDGET ORDINANCE AND ORDINANCE 2021-506-Ε; REQUESTING EMERGENCY PASSAGE UPON INTRODUCTION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, as authorized by Ordinance 2021-506-E, the City and Shands Jacksonville Medical Center, Inc. ("Shands") entered into that certain agreement regarding the distribution of the City's indigent care contract appropriation for fiscal year 2021-2022, made effective as of October 1, 2021 (the "Agreement"), which Agreement provided for \$9,447,306 to be paid by the City directly to Shands, and \$25,552,694 to the State of Florida ("State") for use in the State's Medicaid hospital program for the fiscal year 2021-2022; and

WHEREAS, in order for the State to draw down the total federal funding allotment for State fiscal year 2021-2022, the State requested the City amend its disproportionate share hospital letter of agreement

with the State to provide an additional \$1,259,221 to the State for use in the State's Medicaid hospital program, which will result in an additional \$3,873,515 in disbursements from the State to Shands; and

WHEREAS, Shands has requested the City to amend the Agreement to reduce the City's direct payment to Shands by \$1,259,221 and to provide that amount to the State pursuant to the amended letter agreement authorized hereby; now, therefore,

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Authorization. The Mayor, or his designee, and Corporation Secretary are hereby authorized to: (1) execute and deliver (a) an amended and restated agreement between the City of Jacksonville and Shands Jacksonville Medical Center, Inc. ("Shands"), in substantially the same form as is attached hereto as Exhibit 1 and incorporated herein by this reference, and (b) an amendment to the disproportionate share hospital letter of agreement between the City of Jacksonville and the State of Florida Agency for Health Care Administration, in substantially the same form as are attached hereto as Exhibit 2 and incorporated herein by this reference, which concerns payment and distribution of the City's indigent health care funds in the amount of \$35,000,000 for fiscal year 2021-2022.

Section 2. Requesting emergency passage upon introduction pursuant to Council Rule 4.901 Emergency. Emergency passage upon introduction of this legislation is requested. The nature of the emergency is that the State of Florida must receive the letter agreement authorized hereby by June 30, 2022 in order for Shands to be eligible for the additional funding.

Section 3. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
