4 **ORDINANCE 2022-496-E**

5 AN ORDINANCE WAIVING A PORTION OF SECTION
6 106.201(A) (FINAL ANNUAL BUDGET; TIME OF
7 SUBMISSION), CHAPTER 106 (BUDGET AND ACCOUNTING
8 CODE), *ORDINANCE CODE*, TO ALLOW THE MAYOR TO
9 DELIVER HIS BUDGET ORDINANCES AND BUDGET MESSAGE
10 ON THURSDAY, JULY 21, 2022 AT 9:00 A.M.;
11 DIRECTING THE LEGISLATIVE SERVICES DIVISION TO
12 NOTICE THE CITY COUNCIL SPECIAL MEETING FOR THE
13 MAYOR'S BUDGET ADDRESS; REQUESTING EMERGENCY
14 PASSAGE UPON INTRODUCTION; PROVIDING AN
15 EFFECTIVE DATE.

17 **WHEREAS**, Section 106.201(a), *Ordinance Code*, requires the
18 Mayor to submit the final annual budget proposal for the general
19 government to the City Council by filing a copy with Legislative
20 Services prior to the first City Council Committee meeting in July;
21 and

22 **WHEREAS**, Section 106.201(a), *Ordinance Code*, further requires
23 the annual budget proposal be accompanied by the Mayor's budget
24 message, by a proposed budget ordinance and by the capital improvement
25 plan, capital improvement plan budget, a current debt schedule
26 including amounts outstanding and amortization schedules for all City
27 debt outstanding, and a projection of forecasted General Fund revenues
28 and expenditures for the four years immediately following the
29 succeeding year's budget proposal; and

30 **WHEREAS**, the Council desires to have the Mayor give his budget
31 message on Thursday, July 21, 2022 at 9:00 a.m.; now therefore

1 **BE IT ORDAINED** by the Council of the City of Jacksonville:

2 **Section 1. Waiver of a portion of Section 106.201(a),**
3 **Ordinance Code.** A portion of Section 106.201(a) (Final Annual Budget;
4 Time of Submission), Chapter 106 (Budget and Accounting Code),
5 *Ordinance Code*, is hereby waived to allow the Mayor to deliver his
6 budget proposal, including the budget ordinances, schedules and
7 projections described above, and budget message on Thursday, July 21,
8 2022 at 9:00 a.m.

9 **Section 2. Directing Legislative Services to Notice the**
10 **City Council Special Meeting.** The Legislative Services Division is
11 hereby directed to publicly notice the City Council special meeting
12 for the Mayor's budget address at 9:00 a.m. on Thursday, July 21,
13 2022.

14 **Section 3. Requesting Emergency Passage Upon Introduction**
15 **Pursuant to Council Rule 4.901 Emergency.** Emergency passage upon
16 introduction of this legislation is requested. The nature of the
17 emergency is that Section 106.201(a), *Ordinance Code*, requires the
18 Mayor to submit the final annual budget proposal and deliver the
19 Mayor's budget message to the City Council prior to the first City
20 Council Committee meeting in July, which is scheduled for July 18th
21 at 9:00 a.m. Due to the Council break, immediate action of Council
22 is required as the Council would not have time to consider this
23 request prior to the proposed date for submission of the final annual
24 budget proposal and the Mayor's budget message on July 21st at 9:00
25 a.m.

26 **Section 4. Effective Date.** This Ordinance shall become
27 effective upon signature by the Mayor or upon becoming effective
28 without the Mayor's signature.
